No. PA/Khyber Pakhtunkhwa/Bills/2017/18503.—The Khyber Pakhtunkhwa Mineral Sector Governance (Amendment) Bill, 2017 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 23rd May, 2017 and assented to by the Governor of the Khyber Pakhtunkhwa on 29th May, 2017 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

THE KHYBER PAKHTUNKHWA MINERAL SECTOR GOVERNANCE (AMENDMENT) ACT, 2017 (KHYBER PAKHTUNKHWA ACT NO. XXI OF 2017)

(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa, (Extraordinary), dated the 1st June, 2017).

to amend the Khyber Pakhtunkhwa Minerals Sector Governance Act, 2016.

Whereas, it is expedient further to amend the Khyber Pakhtunkhwa Minerals Sector Governance Act, 2016 (Khyber Pakhtunkhwa Act No. 1 of 2017) for the purposes hereinafter appearing;

It is hereby enacted as follows:

1. Short title and commencement.---(1) This Act may be called the Khyber Pakhtunkhwa Minerals Sector Governance (Amendment) Act, 2017.

- (2) It shall come into force at once.
- 2. Amendment of section 9A of the Khyber Pakhtunkhwa Act No. 1 of 2017.--- In the Khyber Pakhtunkhwa Minerals Sector Governance Act, 2016 (Khyber Pakhtunkhwa Act No. 1 of 2017), in section 9A, the words and commas "in unavoidable circumstances," shall be omitted.
