to amend the Khyber Pakhtunkhwa Right to Information (Amendment) Act, 2015

WHEREAS it is expedient to amend the Khyber Pakhtunkhwa Right to Information (Amendment) Act, 2015 (Khyber Pakhtunkhwa Act No. XXIV of 2015), for the purpose hereinafter appearing;

It is hereby enacted as follows:

- 1. Short title and commencement.——(1) This Act may be called the Khyber Pakhtunkhwa Right to Information (Second Amendment) Act, 2015.
- (2) It shall come into force at once and shall be deemed to have taken effect from the date of commencement of the Khyber Pakhtunkhwa Act No. XXIV of 2015.
- 2. Deletion of section 3 of Act No. XXIV of 2015.— In the Khyber Pakhtunkhwa Right to Information (Amendment) Act, 2015 (Khyber Pakhtunkhwa Act No. XXIV of 2015), section 3 shall be deleted.
