No. PA/NWFP/Legis-I/2003/18828.—The North-West Frontier Province Amendment of Certain Laws (Amendment) Bill, 2003 having been passed by the Provincial Assembly of North-West Frontier Province on the 28th June, 2003 and assented to by the Governor of the North-West Frontier Province on 6th July, 2003 is hereby published as an Act of the Provincial Legislature of the North-West Frontier Province.

THE NORTH-WEST FRONTIER PROVINCE AMENDMENT OF CERTAIN LAWS (AMENDMENT) ACT, 2003.

(N.-W.F.P. ACT NO. IX OF 2003)

[first published after having received the assent of the Governor of the North-West Frontier Province in the Gazette of the N.-W.F.P. (Extraordinary), dated the 8th July, 2003].

AN ACT

further to amend certain laws in their application to the North-West Frontier Province.

<u>Preamble.</u> WHEREAS it is expedient further to amend certain laws in their application to the North-West Frontier Province for the purpose hereinafter appearing;

It is hereby enacted as follows:-

- 1. <u>Short title and commencement.</u>— (1) This Act may be called the North-West Frontier Province (Amendment of certain laws) (Amendment) Act, 2003.
  - (2) It shall come into force at once.
- 2. <u>Amendment of section 9 of Act II of 1899.</u>— In the Stamp Act, 1899 (II of 1899), in its application to the North-West Frontier Province, in section 9,-
  - (i) in clause (d), the full-stop appearing at the end shall be replaced by a semi colon and the word "and" shall be added; and
  - (ii) after clause (d), as so amended, the following new clause (e) shall be added, namely:
    - "(e) exempt from payment of duties either in whole or in part in respect of the instrument executed by Shaukat Khanum Memorial, Cancer Hospital and Research Centre Lahore, for the transfer of a house, measuring 54 marlas donated by Raja Haq Nawaz Kiyani, son of Raja Ali Akbar Khan resident of Azeem House, Mohallah Bandi Rajgan, Kot Najibullah, Haripur District."
- 3. Amendment of section 78 of Act No. XVI of 1908.— In the Registration Act, 1908 (XVI of 1908), in its application to the North-West Frontier Province, in section 78, the full-stop appearing at the end of the third proviso shall be replaced by a colon and thereafter the following new proviso shall be added, namely:

"Provided also that the Provincial Government may, by notification in the official Gazette, exempt from payment of registration fee, either in whole or in part, in respect of the instrument executed by Shaukat Khanum Memorial, Cancer Hospital and Research Centre Lahore, for the transfer of a house measuring 54 marlas donated by Raja Haq Nawaz Kiyani, son of Raja Ali Akbar Khan resident of Azeem House, Mohallah Bandi Rajgan, Kot Najibullah, Haripur District."

4. <u>Repeal.</u>— The North-West Frontier Province Amendment of Certain Laws (Amendment) Ordinance, 2003 (N.W.F.P. Ordinance No. III of 2003) is hereby repealed.
