further to amend the North-West Frontier Province Hydel Development Fund Ordinance, 2001.

<u>Preamble.</u>— WHEREAS it is expedient further to amend the North-West Frontier Province Hydel Development Fund Ordinance, 2001 (N.-W.F.P. Ord. No. XXVI of 2001), for the purposes hereinafter appearing;

It is hereby enacted as follows:-

1. Short title and commencement. (1) This Act may be called the North-West Frontier Province Hydel Development Fund (Amendment) Act, 2006.

- (2) It shall come into force at once.
- 2. <u>Amendment of section 3 of N.-W.F.P. Ord. No. XXVI of 2001.</u> In the North-West Frontier Province Hydel Development Fund Ordinance, 2001 (N.-W.F.P. Ord. No. XXVI of 2001), hereinafter referred to as the said Ordinance, in section 3, after sub-section (8), the following new sub-section shall be added, namely:
 - "(9) An Investment Committee, consisting of the following, shall be constituted to make recommendation to the Board for making investment out of the Fund:

1. Chief Secretary to Government ... Chairman

2. Secretary to Government, ... Member Irrigation and Power Department.

3. Secretary to Government, ... Member Finance Department

4. Managing Director, SHYDO ... Member

5. Director Finance and Administration, SHYDO ... Member."

- 3. <u>Amendment of section 4 of N.-W.F.P. Ord. No. XXVI of 2001.</u>— In the said Ordinance, in section 4, in sub-section (3), for the word "three", the word "four" shall be substituted.
- 4. Amendment of section 7 of N.-W.F.P. Ord. No. XXVI of 2001.—In the said Ordinance, in section 7.—
 - (a) in sub-section (1) and (3), for the words "Irrigation and Power Department", the words "Finance Department" shall be substituted; and
 - (b) in sub-section (2), for words "Chief Secretary", the words "Secretary Finance" shall be substituted.
- 5. Repeal.— The North-West Frontier Province Hydel Development Fund (Amendment) Ordinance, 2006 (N.-W.F.P. Ord. No. II of 2006) is hereby repealed.
