No.PA/NWFP/Bills/2010/3981. The North-West Frontier Province Local Government (Amendment) Bill. 2010 having-been passed by the Provincial Assembly of North-West Frontier Province on 25th January. 2010 and assented to by the Governor of the North-West Frontier Province on 28th January. 2010 is hereby published as an Act of the Provincial Legislature of the North-West Frontier Province.

## THE NORTH-WEST FRONTIER PROVINCE LOCAL GOVERNMENT (AMENDMENT) ACT, 2010.

(N-W.F.P. ACT NO. III OF 2010)

(First published after having received the assent of the Governor of the North-West Frontier Province in the Gazette of the N.-W.F.P. (Extraordinary), Dated the 30th January, 2010).

### AN

further to amend the North-West Frontier Province Local Government Ordinance, 2001.

WHEREAS it is expedient further to amend the North-West Frontier Province Local Government Ordinance. 2001 (N.-W.F.P. Ord No. XIV of 2001), to provide for transitional arrangements in the interregnum to next election of local government;

It is hereby enacted as follows:-

- 1. <u>Short title and commencement.</u>—(1) This Act may be called the North-West Frontier Province Local Government (Amendment) Act, 2010.
  - (2) It shall come into force at once.
- 2. <u>Insertion of section 179-B in N.-W.F.P. Ord No. XIV of 2001.</u> In the North-West Frontier Province Local Government Ordinance, 2001 (N.-W.F.P. Ord No. XIV of 2001), after section 179-A, the following new section shall be inserted, namely:
  - "179-B. <u>Dissolution of Local Councils and Transitional Arrangements.</u>—(1) Notwithstanding anything contained in this Ordinance, the Government may, on coming into force of the North-West Frontier Province Local Government (Amendment) Act, 2010, by notification in the Official Gazette, shall dissolve the Zilla Councils, Tehsil Councils, Town Councils and Union Councils and in consequence thereof, all Nazimeen, Naib Nazimeen and other members of Zilla Councils, Tehsil Councils, Town Councils and Union Councils in the province shall cease to hold their respective offices on the said date.
  - (2) Soon after the dissolution of the Local Councils, the Government shall appoint an Administrator for a local government, who shall perform functions and exercise powers, under this Ordinance or any other law, of the Nazim, Naib Nazim and Local Council of the concerned local government.
  - (3) The Government may from time to time issue directions to the Administrators in the performance of their functions or exercise of powers.".
