THE NORTH-WEST FRONTIER PROVINCE PROCUREMENT OF GOODS, WORKS, SERVICES AND CONSULTING SERVICES (AMENDMENT) ORDINANCE, 2002.

N.-W.F.P. ORDINANCE NO. XLII OF 2002.

#### AN ORDINANCE

to amend the North-West Frontier Province Procurement of Goods, Works, Services and Consulting Services Ordinance, 2002.

WHEREAS it is expedient to amend the North-West Frontier Province Procurement of Goods, Works, Services and Consulting Services Ordinance, 2002 (N.-W.F.P. Ord. No. XVIII of 2002), for the purpose hereinafter appearing;

AND WHEREAS the Governor of the North-West Frontier Province is satisfied that circumstances exist which render it necessary to take immediate action;

NOW, THEREFORE, in pursuance of the Proclamation of Emergency of the fourteenth day of October, 1999, as amended uptodate, and the Provisional Constitution Order No. 1 of 1999, read with Article 4 of the Provisional Constitution (Amendment) Order No. 9 of 1999, and in exercise of all powers enabling him in that behalf, the Governor of the North-West Frontier Province is pleased to make and promulgate the following Ordinance:

- 1. <u>Short title and commencement.</u>— (1) This Ordinance may be called the North-West Frontier Province Procurement of Goods, Works, Services and Consulting Services (Amendment) Ordinance, 2002.
  - (2) It shall come into force at once.

- 2. Amendment of section 2 of N.-W.F.P. Ord, NO. XVIII 2 2002.— (1) In the North-West Frontier Province Procurement of Goods, Works, Services an Consulting Services (Amendment) Ordinance, 2002 (N.-W.F.P. Ord. No. XVIII of 2002), here nafter referred to as the said Ordinance, in section 2, for clause (c), the following shall be substituted, namely:
  - "(c) 'Committee' means the Departmental Consultant Selection Committee or, as the case may be, the District Consultant Selection Committee, established under section 3 of this Ordinance;".
- 3. <u>Amendment of section 3 of N.-W.F.P. Ord. No. XVIII of 2002.</u>— In the said Ordinance, for section 3, the following shall be substituted, namely:
  - "3. Establishment of Committees.— (1) As soon as may be after the commencement of this Ordinance, a Procuring Entity shall establish a Committee to be known as 'the Departmental Consultant Selection Committee'. The Committee shall comprise of such members, and shall exercise such powers and perform such functions, as may be prescribed.
  - (2) The District Government concerned shall establish for each District a District Consultant Selection Committee, which shall consist of such members, exercise such powers and perform such functions as may be prescribed.".
