No. PA/NWFP/Bills/2010/10573.—The North-West Frontier Province Provincial Assembly (Powers, Immunities and Privileges) (Amendment) Bill, 2010 having been passed by the Provincial Assembly of North-West Frontier Province on 11th March, 2010 and assented to by the Governor of the North-West Frontier Province on 16th March, 2010 is hereby published as an Act of the Provincial Legislature of North-West Frontier Province.

THE NORTH-WEST FRONTIER PROVINCE PROVINCIAL ASSEMBLY (POWERS, IMMUNITIES AND PRIVILEGES) (AMENDMENT) ACT, 2010

(N.-W.F.P ACT NO. V OF 2010)

AN ACT

further to amend the North-West Frontier Province Provincial Assembly (Powers, Immunities and Privileges) Act, 1988.

<u>Preamble.</u>- WHEREAS it is expedient further to amend the North-West Frontier Province Provincial Assembly (Powers, Immunities and Privileges) Act, 1988 (N.W.F.P. Act No. IX of 1988), for the purposes hereinafter appearing;

It is hereby enacted as follows:-

- 1. <u>Short title and commencement.---</u> (1) This Act may be called the North-West Frontier Province Provincial Assembly (Powers, Immunities and Privileges) (Amendment) Act, 2010.
 - (2) It shall come into force at once.
- 2. <u>Insertion of new section 7 in the N.W.F.P. Act No. IX of 1988.</u>—After the existing section 6 of the said Act the following new section 7 may be inserted, namely:-
- "7. <u>Power to preside a meeting</u>.--- (1) Any meeting convened by the Government or Semi-Government institution or autonomous body, in which Member is supposed to participate shall be presided over by the Member:

Provided that where the Governor or a Federal Minister is present, the Member shall not preside over the meeting.

- (2) In case where more than one Member is to participate in the meeting, the presiding Member shall be;
 - (i) through consensus among members; or
 - (ii) through voting among members."
