No. PA/NWFP/Legis:1/2005/3211--- The North-West Frontier Province Provinceal Assembly (Powers, Immunities and Privileges) (Amendment) Bill, 2005 having been passed by the Provincial Assembly of North-West Frontier Province on the 3<sup>rd</sup> February, 2005 and assented to by the Governor of the North-West Frontier Province on 9<sup>th</sup> February, 2005 is hereby published as an Act of the Provincial Legislature of the North-West Frontier Province.

# THE NORTH-WEST FRONTIER PROVINCE PROVINCIAL ASSEMBLY (POWERS, IMMUNITIES AND PRIVILEGES) (AMENDMENT) ACT, 2005.

to amend the North-West Frontier Province Provincial Assembly (Powers, Immunities and Privileges) Act, 1988.

Preamble.- WHEREAS it is expedient to amend the North-West Frontier Province Provincial Assembly (Powers, Immunities and Privileges) Act, 1988 (N.-W.F.P. Act No. IX of 1988), for the purposes hereinafter appearing;

It is hereby enacted as follows:-

1: Short title and commencement.—— (1) This Act may be called the North-West Frontier Province Provincial Assembly (Powers, Immunities and Privileges) (Amendment) Act, 2005.

- (2) It shall come into force at once.
- 2. Amendment of section 25 of the N.W.F.P. Act No. IX of 1988.—In the North-West Frontier Province Provincial Assembly (Powers, Immunities and Privileges) Act, 1988 (N.W.F.P. Act No. IX of 1988) hereinafter referred to as the said Act, in section 25, in column No. 2 of the schedule, in serial No. 28, the words "in the precincts of the Assembly" shall be deleted.
