No. PA/NWFP/Legis:1/2004/28557.—The North-West Frontier Province Repeal of the Agricultural Produce Markets (Repeal) Bill, 2004, having been passed by the Provincial Assembly of North-West Frontier Province on the 11th October, 2004 and assented to by the Governor of the North-West Frontier Province on 16th October, 2004 is hereby published as an Act of the Provincial Legislature of the North-West Frontier Province.

THE NORTH-WEST FRONTIER PROVINCE REPEAL OF THE AGRICULTURAL PRODUCE MARKETS (REPEAL) ACT, 2004.

(N.-W.F.P. ACT NO. VII OF 2004)

[First published after having received the assent of the Governor of the North-West Frontier Province in the Gazette of the N.-W.F.P. (Extraordinary), dated the 22nd October, 2004].

to repeal the North-West Frontier Province Agricultural Produce Markets (Repeal) Ordinance, 2002.

Preamble.—WHEREAS it is expedient to repeal the North-West Frontier Province Agricultural Produce Markets (Repeal) Ordinance, 2002 (N.-W.F.P. Ord. No. XXXVIII of 2002), and to revive the Agricultural Produce Markets Act, 1939 (Pb. Act No. V of 1939), as applicable in the North-West Frontier Province immediately before its repeal;

It is hereby enacted as follows:

1. Short title and commencement.—(1) This Act may be called the North-West Frontier Province Repeal of the Agricultural Produce Markets (Repeal) Act, 2004.

- (2) It shall come into force at once and shall be deemed to have taken effect on the 5th October, 2002.
- 2. Repeal of N.-W.F.P. Ord. No. XXXVIII of 2002 and revival of Pb. Act V of 1939.—(1) The North-West Frontier Province Agricultural Produce Markets (Repeal) Ordinance, 2002 (N.-W.F.P. Ord. No. XXXVIII of 2002), is hereby repealed and shall be deemed to have been so repealed with effect from the 5th October, 2002, as if it had never come into force.
- (2) Consequent upon the repeal of the North-West Frontier Province Agricultural Produce Markets (Repeal) Ordinance, 2002 (N.-W.F.P. Ord. No. XXXVIII of 2002), under sub-section (1), the Agricultural Produce Markets Act, 1939 (Pb. Act No. V of 1939), as applicable in the North-West Frontier Province immediately before its repeal, shall stand revived and, for all intents and purposes, be deemed to have been so revived with effect from the 5th October, 2002, as if it had never been repealed.
- 3. Repeal.—The North-West Frontier Province Repeal of the Agricultural Produce Markets (Repeal) Ordinance, 2004 (N.-W.F.P. Ord. No. II of 2004) is hereby repealed.
