No. PA/NWFP/Legis-I/2003/17343.—The North-West Frontier Province Urban Immovable Property Tax (Amendment) Bill, 2003. having been passed by the Provincial Assembly of North-West Frontier Province on 10th June, 2003 and assented to by the Governor of the North-West Frontier Province on 15th June, 2003 is hereby published as an Act of the Provincial Legislature of the North-West Frontier Province.

THE NORTH-WEST FRONTIER PROVINCE URBAN IMMOVABLE PROPERTY TAX (AMENDMENT) ACT, 2003.

(N.W.F.P. ACT NO. IV OF 2003)

[First published after having received the assent of the Governor of the North-West Frontier Province in the Gazette of the N.W.F.P. (Extraordinary), dated the 20th June, 2003.]

AN ACT

further to amend the West Pakistan Urban Immovable Property Tax Act, 1958, and to defer the enforcement of the North-West Frontier Province Urban Immovable Property Tax (Amendment) Ordinance, 2001.

Preamble.— WHEREAS it is expedient further to amend the West Pakistan Urban Immovable Property Tax Act, 1958 (W.P. Act No. V of 1958), and to defer the enforcement of the North-West Frontier Province Urban Immovable Property Tax (Amendment) Ordinance, 2001 (N.-W.F.P. Ordinance No. XV of 2001), in the manner hereinafter appearing;

It is hereby enacted as follows:

- 1. Short title and commencement.—(1) This Act may be called the North-West Frontier Province Urban Immovable Property Tax (Amendment) Act, 2003.
 - (2) It shall come into force at once.
- 2. Amendment of Schedule to W.P. Act No. V of 1958,—In the West Pakistan Urban Immovable Property Tax Act, 1958 (W.P. Act No V of 1958),—
 - (i) in SCHEDULE-I, in the entries at Serial No. 4, for the existing entry at clause (c), the following shall be substituted, namely:
 - "(c) total of (a) and (b), multiplied by locality factor."; and
 - (ii) in SCHEDULE-II, in the entries at Serial No. 5, for the existing entry at clause (c), the following shall be substituted, namely:
 - "(c) total of (a) and (b), multiplied by locality factor.".
- 3. Amendment of section I of N.-W.F.P. Ord, No. XV of 2001,—In the North-West Frontier Province Urban Immovable Property Tax (Amendment) Ordinance, 2001 (N.-W.F.P. Ord. No. XV of 2001), in section 1, for sub-section (2), the following shall be substituted and shall always be deemed to have been so substituted, namely:
 - "(2) It shall come into force on the first day of July, 2002.".
- 4. Repeal.—The North-West Frontier Province Urban Immovable Property Tax (Amendment) Ordinance, 2003 (N.-W.F.P. Ord. No. V of 2003), is hereby repealed.
