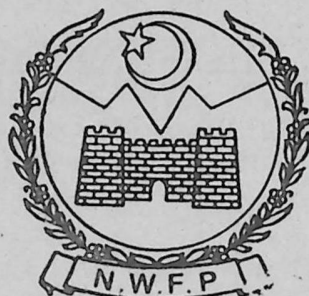

No. PANWFP/Legis-I/2003/17323.—The Provincial Assembly of the North-West Frontier Province (Salaries and Allowances of Members) (Amendment) Bill, 2003 having been passed by the Provincial Assembly of North-West Frontier Province on 11th June, 2003 and assented to by the Governor of the North-West Frontier Province on 15th June, 2003 is hereby published as an Act of the Provincial Legislature of the North-West Frontier Province.

*further to amend the Provincial Assembly of the North-West Frontier Province
(Salaries and Allowances of Members) Act, 1974.*

Preamble.— WHEREAS it is expedient further to amend the Provincial Assembly of the North-West Frontier Province (Salaries and Allowances of Members) Act, 1974 (N.-W.F.P. Act No. XI of 1974), in the manner hereinafter appearing;

It is hereby enacted as follows:

1. **Short title and commencement.**—(1) This Act may be called the Provincial Assembly of the North-West Frontier Province (Salaries and Allowances of Members) (Amendment) Act, 2003.

(2) It shall come into force at once and shall be deemed to have taken effect from the 25th November, 2002.

2. **Insertion of section 7B of N.-W.F.P. Act No. XI of 1974.**—In the said Act, after section 7A, the following new section '7B' shall be inserted, namely:

"7B. **Accommodation Allowance.**—Where official accommodation is not provided to a Member, he shall be paid an accommodation allowance at the rate of one thousand and six hundred rupees per day for the period of residence on duty:

Provided that a Member shall not be required to produce any written certificate while claiming accommodation allowance under this section."
