No. PA/NWFP/Legis-I/2003/17323.—The Provincial Assembly of the North-West Frontier Province (Salaries and Allowances of Members) (Amendment) Bill, 2003 having been passed by the Provincial Assembly of North-West Frontier Province on 11th June, 2003 and assented to by the Governor of the North-West Frontier Province on 15th June, 2003 is hereby published as an Act of the Provincial Legislature of the North-West Frontier Province.

AN ACT

further to amend the Provincial Assembly of the North-West Frontier Province (Salaries and Allowances of Members) Act, 1974.

Preamble.— WHEREAS it is expedient further to amend the Provincial Assembly of the North-West Frontier Province (Salaries and Allowances of Members) Act, 1974 (N.-W.F.P. Act No. XI of 1974), in the manner hereinafter appearing;

It is hereby enacted as follows:

- 1. <u>Short title and commencement.</u>—(1) This Act may be called the Provincial Assembly of the North-West Frontier Province (Salaries and Allowances of Members) (Amendment) Act, 2003.
- (2) It shall come into force at once and shall be deemed to have taken effect from the 25th November, 2002.
- 2. <u>Insertion of section 7B of N.-W.F.P. Act No. XI of 1974</u>,—In the said Act, after section 7A, the following new section '7B' shall be inserted, namely:
 - "7B. <u>Accommodation Allowance.</u>—Where official accommodation is not provided to a Member, he shall be paid an accommodation allowance at the rate of one thousand and six hundred rupees per day for the period of residence on duty:

Provided that a Member shall not be required to produce any written certificate while claiming accommodation allowance under this section.".
