No.PA/KP/Bills/2010/36924.—The Provincial Motor Vehicles (Khyber Pakhtunkhwa) (Amendment) Bill, 2010 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 21st September, 2010 and assented to by the Governor of the Khyber Pakhtunkhwa on 28th September, 2010 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

THE PROVINCIAL MOTOR VEHICLES (KHYBER PAKHTUNKHWA) (AMENDMENT) ACT, 2010.

(KHYBER PAKHTUNKHWA ACT NO. XII OF 2010)

(first published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa (Extraordinary), dated the 1st October, 2010).

ACT

further to amend the Provincial Motor Vehicles Ordinance, 1965.

WHEREAS it is expedient further to amend the Provincial Motor Vehicles Ordinance, 1965 (W.P. Ord. No. XIX of 1965), for the purposes hereinafter appearing;

It is hereby enacted as follows:-

1. **Short title and commencement.**— (1) This Act may be called the Provincial Motor Vehicles (Khyber Pakhtunkhwa) (Amendment) Act, 2010.

(2) It shall come into force at once.

2. **Amendment of section 25 of W.P. Ord. No. XIX of 1965.**—In the Provincial Motor Vehicles Ordinance, 1965 (W.P. Ord. No. XIX of 1965), in section 25,—

(i) for sub-section (3), the following shall be substituted, namely:

"(3) The registering authority shall assign to motor vehicles for display thereon, in the prescribed manner, a distinguishing mark (in this Ordinance referred to as registration mark), containing the name of the province, the name of the district where the vehicle is registered and such letter or group of letters and figures as may be prescribed:

Provided that after coming into force of the Provincial Motor Vehicles (Khyber Pakhtunkhwa) (Amendment) Act, 2010, the owners of motor vehicles to whom personalized numbers were issued, shall cease to display these number plates hence forth and shall start to display the number plates provided to them under sub-section (6):

Provided further that an amount of twenty-five thousand rupees received from each owner of vehicle to whom personalized number was issued, shall be refunded to them as per prescribed procedure.";

(ii) sub-section (3A) shall be deleted; and

(iii) for sub-section (9), the following shall be substituted, namely:

"(9) Any person found using the number plate other than the one provided to him under sub-section (6) or a registration mark other than the one he is allowed to use under sub-section (8) shall be liable to a penalty of five thousand rupees in violation of misuse of registration mark."

3. **Repeal:**—The Provincial Motor Vehicles (Khyber Pakhtunkhwa) (Amendment) Ordinance, 2010 (Khyber Pakhtunkhwa Ordinance No. I of 2010) is hereby repealed.
