No.PA/ Khyber Pakhtunkhwa/Bills/2011/50692.—The Provincial Assembly of Khyber Pakhtunkhwa Speaker and Deputy Speaker's (Salaries, Allowances & Privileges) (Amendment) Bill, 2011 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 3rd October, 2011 and assented to by the Governor of the Khyber Pakhtunkhwa on 13th October, 2011 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

(first published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa (Extraordinary), dated the 18th October, 2011)

AN

further to amend the Provincial Assembly of Khyber Pakhtunkhwa Speaker & Deputy Speaker's (Salaries, Allowances and Privileges) Act, 1975.

Preamble:- WHEREAS it is expedient further to amend the Provincial Assembly of Khyber Pakhtunkhwa Speaker and Deputy Speaker's (Salaries, Allowances & Privileges) Act, 1975 (Khyber Pakhtunkhwa Act No. III of 1975), for the purposes hereinafter appearing:

It is hereby enacted as follows:

- 1. <u>Short title and commencement:</u> (1) This Act may be called the Provincial Assembly of Khyber Pakhtunkhwa Speaker and Deputy Speaker's (Salaries, Allowances & Privileges) (Amendment) Act, 2011.
- (2) It shall come into force at once and shall be deemed to have taken effect from 29th January, 2009.
- 2. Amendment in section 7A of Khyber Pakhtunkhwa Act No. III of 1975:- In the Provincial Assembly of Khyber Pakhtunkhwa Speaker and Deputy Speaker's (Salaries. Allowances & Privileges) Act, 1975 (Khyber Pakhtunkhwa Act No. III of 1975), hereinafter referred as the said Act, in section 7A, for the words "one telephone" occurring twice, the words "two telephones" shall be substituted.
- 3. Amendment in section 20A of the said Act: In the said Act, in section 20A, for the words "one telephone" before the words "at his office", the words "two telephones" shall be substituted.
- 4. Amendment in section 27 of the said Act. In the said Act, in section 27, for the words "an official car", the words "two official cars" shall be substituted.
