

(REGULATIONS 2007)

AKRAM KHAN DURRANI COLLEGE BANNU

NOTIFICATION

In exercise of the powers conferred by clause (1) of Section 20 of the North West Frontier Province, Government Educational and Training Institutions Ordinance, 1971, N.W.F.P, Ordinance III of 1971, the Board of Governors for Akram Khan Durrani College with approval of government is pleased to make the following regulations namely.

AKRAM KHAN DURRANI COLLEGE REGULATIONS 2007 PART-I-GENERAL

1. Short Title.

These regulations may be called the Akram Khan Durrani College Bannu (Terms & Conditions of Service) Regulations, 2007.

2. Definitions.

In these regulations unless there is anything repugnant to the subject or context,

- a. Government. Government means Government of North West Frontier Province.
- b. College. means Akram Khan Durrani College Bannu.
- c. Board. means the Board of Governors of Akram Khan Durrani College Bannu.
- d. Chairman. means the Chairman Board of Governors Akram Khan Durrani College Bannu.
- e. Principal. means the Principal Akram Khan Durrrani College Bannu.
- f. Competent Authority. means the authority to whom the relevant powers have been delegated under these regulations.
- g. Controlling Authority. means the Chief Minister of N.W.F.P.
- h. Appointing Authority. means the authority specified in these regulations.
- i. Secretary. means Secretary of the Board.
- **j.** Selection Board. means the Selection Board constituted for selection of persons for appointment.
- **k. Selection Committee.** means the committee constituted for selection of persons for appointment to various posts under these regulations.

vi) to frame, subject to approval of Government, regulations for the conduct of business of the Board.

b. The Chairman shall:

- i. Have the authority to take any action that he may consider necessary for the control and efficient management and administration of the college.
- ii. Exercise the powers delegated by the Board from time to time. He shall hold ordinary or extra ordinary meetings of the BoG.
- iii. Act as appellant authority on any action, disciplinary or otherwise relating to promotion, pay & allowances, etc taken by the Principal in case of the employees of the college.

c. The Principal.

The Principal shall hold, control and administer the property and funds of the College on behalf of the Board of Governors and shall be directly responsible to the Board. He shall:-

- i. Exercise powers delegated by the Board of Governors from time to time.
- ii. Exercise academic control over the College, ensuring healthy atmosphere and good results. He shall have powers to make admissions, discharge, and withdrawal of students in accordance with the policy laid down by the Board. He will be accountable to the Chairman BoG.
- iii. Recommend to the BoG, all appointments made in BPS-17 and above in accordance with the laid down policy of the Board. He shall have powers to make appointments on contract during emergency. Such cases shall be reported to the BoG in the next meeting for confirmation.
- , iv. be the appointing authority for the appointment of employees /teachers in BPS 16 & below.
- v. Have the power to enter into contracts for the purpose of carrying out the business of the College, subject to approval of BoG.
- vi. Exercise any other powers delegated or duties assigned by the Board.

6. Method of Appointment:

Appointment to various posts shall be made by initial recruitment, by promotion or by transfer on deputation as the Board may determine from time to time.

- i. No person shall be appointed to a post by initial recruitment who is not within the age limit prescribed by the Board for the post, provided, that where a person with in the prescribed age limit is not available and it is not in the interest of the college to keep the post vacant till next recruitment, the Principal may accord the age relaxation up to five (5) years on case to case basis.
- ii. The age shall be reckoned from the last date of submission of application.

7. Qualifications:

No person shall be appointed to a post by initial recruitment or by transfer unless he/she possesses the qualification prescribed for the post.

8. Appointment of Persons on Contract:

The Appointing Authority may, on such terms and conditions as he may specify in each case, appoint persons on contract basis, or on work charge basis or who are paid out of contingencies.

Part-IV Conditions of Services

9. Probation.

- a. A person appointed to a post on regular basis shall remain on probation for a period of two years, if appointed by initial recruitment, and for a period of one year, if appointed otherwise; provided that if his work or conduct during the period of probation has, in the opinion of the appointing authority, not been found satisfactory, the appointing authority may, notwithstanding that the period of probation has not expired
 - i. dispense with his service, if he has been appointed by initial recruitment; or
