Preamble.---WHEREAS it is expedient to provide for the establishment of a University at Peshawar in the name of Abasyn University, in the private sector, and for matters ancillary thereto:

It is hereby enacted as follows:

CHAPTER -I PRELIMINARY

1. Short title and commencement.--- (1) This Act may be called the Abasyn University Act. 2009

It shall come into force at once and shall be deemed to have taken effect from 1st (2)March, 2008.

Definitions .--- In this Act, unless there is anything repugnant in the subject or context,--

CHAPTER-II THE UNIVERSITY

Incorporation --- (1) There shall be established at Peshawar a University to be called Abasyn 3. University.

the members of the Authorities of the University established under section 16; all University Teachers, Researchers and persons recognized as students of the (b)

University in accordance with terms prescribed from time to time; and (c)

The University shall be a body corporate by the name of Abasyn University having

perpetual succession and a common seal, and may sue and be sued by the said name. The University shall be competent to acquire and hold property, both movable and

(4) The University shall be competent to acquire and immovable property which may immovable, and to lease, sell or otherwise transfer any movable and immovable property which may have become vested in or been acquired by it.

Notwithstanding anything contained in any other law for the time being in force, the University shall have academic, financial and administrative autonomy, including the power to employ officers, teachers and other employees on such terms as may be prescribed, subject to the terms of this Act and the Higher Education Commission Ordinance, 2002. In particular, and without prejudice to the authority granted to the Commission by the law, the Government or any authority or auditor appointed by the Government shall have no power to question the policy underlying the allocation of resources approved by the Senate in the annual budget of the University.

Powers of the University .--- The University shall have the following powers, namely:

- to provide for education and scholarship in such branches of knowledge as it may deem fit, and to make provision for research, service to society and for the application, advancement and dissemination of knowledge in such manner as it may determine;
- to prescribe courses of studies to be conducted by it and the colleges: (ii)

to hold examinations and to award and confer degrees, diplomas, certificates (iii) and other academic distinctions to and on persons who have been admitted to and have passed its examinations under prescribed conditions;

- to prescribe the terms and conditions of employment of the officers, teachers (iv) and other employees of the University and to lay down terms and conditions servants in that may be different from those applicable to government general;
- to engage, where necessary, persons on contracts of specified duration and to (v) specify the terms of each engagement;
- to confer honorary degrees or other distinctions on approved persons in the (vi) manner prescribed;

- to provide for such instruction for persons not being students of the University as it may prescribe, and to grant certificates and diplomas to such persons;

to institute programmes for the exchange of students and teachers between the University and att the University and other universities, educational institutions and research organisations, inside as well as outside Pakistan;

- (xxiii) to provide for the residence of the students of the University and colleges, to institute and maintain halls of residence and to approve license hostels and lodging;
- (xxiv) to maintain order, discipline and security on the campuses of the University
- (xxv) to promote the extra curricular and recreational activities of such studen and to make arrangements for promoting their health and general welfare.
- (xxvi) to demand and receive such fees and other charges as it may determine;

(xxvii) to make provision for research, advisory or consultancy services and these objectives to enter into arrangements with other institutions, public private bodies, commercial and industrial enterprises under preservices conditions;

(xxviii) to enter into, carry out, vary or cancel contracts;

(xxix) to receive and manage property transferred and grants, contributions made the University and to invest any fund representing such property, gran bequests, trusts, gifts, donations, endowments or contributions in : manner as it may deem fit;

(xxx) to provide for the printing and publication of research and other works; a

(xxxi) to do all such other acts and things, whether incidental to the pove aforesaid or not, as may be requisite or expedient in order to further objectives of the University as a place of education, learning, and research

5. <u>University open to all classes, creeds, etc.</u>--(1) The University shall be open to all pereof either gender and of whatever religion, race, creed, class, colour or domicile and no person e be denied the privileges of the University on the grounds of religion, race, caste, creed, class, color domicile.

(2) An increase in any fee or charge that is in excess of ten percent per annum on only with the approval of the Chancellor.

(3) The University shall institute financial aid programmes for students in need, to access to the University and the various opportunities provided by it to be based on merit rather ability to pay.

The Patron shall, when present, preside at the Convocation of the University or he Day authorize the Chancellor or any other person to perform this function in his absence.

Every proposal to confer an honorary degree shall be subject to confirmation by the (3)Patron:

Chancellor.---(1) Mr. Mohammad Imran Ullah, the Chief Executive of the Abasyn Education System (Pvt.) Limited, Peshawar shall be the first Chancellor of the University on such lems and conditions as the Board of Directors may determine.

(4) If the Chancellor is satisfied that serious irregularity or mismanagement with respect to the affairs of the University has occurred, he may,-

 (a) as regards proceedings of the Senate, direct that specified proceedings be reconsidered and appropriate action taken within one month of the direction having been issued:

Provided that if the Chancellor is satisfied that either no reconsideration has been carried out or that the reconsideration has failed to address the concern expressed he may, after calling upon the Senate to show cause in writing, appoint a five member Review Panel to examine and report to the Chancellor on the functioning of the Senate. The report of the Review Panel shall be submitted within such time as may be prescribed by the Chancellor. The Review Panel shall be drawn from persons of eminence in academics and in the fields of law, accountancy and administration; and

(b) as regards proceedings of any Authority or with respect to matters within the competence of any Authority other than the Senate, direct the Senate to exercise powers under section 18.

10. <u>Removal from the Senate.</u>---(1) The Chancellor may, upon the recommendation of the Review Panel, remove any person from the membership of the Senate on the ground that such person:

- (a) has become of unsound mind; or
- (b) has become incapacitated to function as member of the Senate: or
- .(c) has been convicted by a court of law for an offence involving moral turpitude; or

(d) has absented himself from two consecutive meetings without just cause; or

(e) has been guilty of misconduct, including use of position for personal advantage of any kind, or gross inefficiency in the performance of functions.

(2) The Chancellor shall remove any person from the membership of the Senate on a resolution calling for the removal of such person supported by at least three-fourths of the membership of the Senate:

Provided that before passing such resolution the Senate shall provide the member concerned a fair hearing;

The minimum qualifications necessary for appointment to the post of the Controller of (2)Examinations shall be as may be prescribed.

The term of office of the Controller of Examinations shall be three years and may be (4)renewed from time to time:

Where this Act makes any provision for anything to be done but no provision or no sufficient provision has been made as respects the authority by whom, or the time at which, or the manner in which, it shall be done, then it shall be done by such authority, at such time, or in such manner as the Chancellor may direct after obtaining done by such authority, at such time, or in such manner as the Chancellor may direct after obtaining the views of the Senate.

- Faculty of Natural Sciences; and (e)
- Such other Faculties as may be determined by the Senate. (1)

Board of Faculty: 2.

There shall be a Board of each Faculty, which shall consist of: (1)

- the Dean of the Faculty: (a)
- one nominee of the Board of Directors: (b)
- the Professors and the Head of the department concerned in the Faculty: (c)
- one nominee, other than Professors and Head of each departments, to be (d) nominated by the respective Heads:
- two teachers to be nominated by the Academic Council by reason of their specialized knowledge of the subjects which, though not assigned to the Faculty, have in the opinion of the Academic Council, important bearing on (e)
 - the subjects assigned to the Faculty: two experts in the field from outside the University to be appointed by the
- (1) Senate: and
 - one nominee to be nominated by the Vice-Chancellor.
- The members, other than ex-officio members, shall hold office for three years. The quorum for a meeting of the Board of a Faculty shall be one half of the total (2)

number of members, a fraction being counted as one.

3. <u>Board of Studies.</u>---(1) There shall be a separate Board of Studies for each subject or group of subjects as may be prescribed by Regulations.

- (2) Each Boards of Studies shall consist of-
 - (a) the Head of the department concerned; and
 - (b) three to five experts or teachers with Ph..D, other than University teachers, to be appointed by the Vice-Chancellor in consultation with the Head of the departments.

(3) The term of office of members of the Board of Studies, other than ex-officio members, shall be three years.

(4) The quorum for meeting of the Board of Studies shall be one half of the total number of members. a fraction being counted as one.

(5) The Head of the departments concerned shall be the Chairperson and convener of the Board of Studies.

4. <u>Functions of the Board of Faculty.</u>—The Board of each Faculty, subject to the general control of the Academic Council and the Senate, shall have the powers to-

- (i) co-ordinate the teaching and research work in the subjects assigned to the Faculty;
- scrutinize the recommendations of the departments comprising the Faculty with regards to the appointment of paper setters and examiners for graduate and post graduate examinations and to forward the panel of suitable paper setters and examiners for each examination to the Vice- Chancellor for approval;
- (iii) consider any other academic matter relating to the Faculty and report thereof to the Academic Council;
- (iv) prepare a comprehensive annual report regarding the performance of each department concerned, comprising the Faculty for presentation to the Academic Council; and
- (v) perform such other functions as may be prescribed by Statutes.

5. <u>Dean of Faculty.</u>---(1) There shall be a Dean of each Faculty, who shall be the Chairperson and Convener of the Board of Faculty.

(2) The Dean shall be appointed by the Senate on the recommendation of the Vice-Chancellor and shall hold office for a period upto three years and shall be eligible for re-

The Dean shall have such powers and perform such duties as may be prescribed by (4) the Senate.

Teaching Department.---(1) There shall be a Teaching Department for each subject or a 6. Teaching Department for each subject or a reaching Department for each subject or a group of subjects, as may be prescribed by Regulations and each Teaching Department shall be at the attead of department.

- The Head of a Teaching Department-(2)
 - shall be appointed by the Senate on the recommendations of the Vice-(a) Chancellor for a period of three years and shall be eligible for re-appointment;
 - shall plan, organize and supervise the work of the Teaching Department and (b) shall be responsible to the Dean for the work of his Teaching Department;
 - shall under the general supervision of the Vice-Chancellor and the Dean. (c) exercise all administrative, financial and academic powers and such other duties and powers as may be assigned or delegated to him; and
 - shall prepare a comprehensive annual report on the performance of the (d) · Teaching Department at graduate and post graduate levels, and on Faculty research and development and submit it to the Dean of the Faculty for evaluation.

Selection Board .--- (1) The Selection Board shall consist of:-

- the Vice-Chancellor (Chairman); (a)
- two nominces of the Board of Directors; (b)
- the Dean of the concerned Faculty: (c)
- one eminent scholar nominated by the Chancellor; and (d)
- Registrar, who shall also be the Secretary of the Board. (e)
- The members, other than ex-officio members, shall hold office for three years.

- The quorum for a meeting of the Selection Board shall be four members. (3)

No member who is a candidate for the post to which appointment is to be made, shall (4)take part in the proceedings of the Board.

In the event of an unresolved difference of opinion between the Selection Board and (2)the Senate, the decision of the Chancellor shall be final.

The Chancellor shall have the power to directly appoint person of exceptional merit (3)on an academic position for a specified period, not exceeding six months, on such terms and conditions as he may determine.

- Finance and Planning Committee.---(1) The Finance and Planning Committee shall consist 9. of
 - the Vice-Chancellor (Chairman): (i)
 - on Dean to be nominated by the Chancellor; (ii)
 - two nominees of the Board of Directors: (iii)
 - (iv) one nominee of the Senate:
 - one nominee of Higher Education Department of the North-West Frontier (1) Province not below the rank of Additional Secretary : and
 - Director Finance, who shall also be the Secretary of the Committee. (vi)
 - The term of office of the nominated members shall be three years. (2)

The quorum for a meeting of the Finance and Planning committee shall be four members.

Functions of the Finance and Planning Committee.--- The functions of the Finance and 10. Planning Committee shall be-

(i)

to prepare the annual statement of accounts, propose annual budget estimates

- (ii) to review periodically the financial position of the University;
- (iii) to prepare long term and short term development plans; and
- (iv) to perform such other functions as may be prescribed by Statutes.
