further to amend the Bank of Khyber Act. 1991.

WHEREAS it is expedient further to amend the Bank of Khyber Act. 1991 (N.-W.F.P. Act No. XIV of 1991), for the purposes hereinafter appearing;

It is hereby enacted as follows:

Short title and commencement.--- (1) This Act may be called the Bank of Khyber 1. (Amendment) Act, 2009.

It shall come into force at once. (2)

N.W.F.P. GOVERNMENT GAZETTE, EXTRAORDINARY, 24th OCTOBER, 2009 Amendment of preamble of N.-W.F.P. Act No. XIV of 1991.--- In the Bank of Khyber Act 286 2. <u>Amendment of preamble of Market Act</u> 1991 (N.-W.F.P. Act No. XIV of 1991), hereinafter referred to as the said Act, in the preainble, for clause (f), the following shall be substituted, namely:

the Bank may, in addition to commercial/conventional banking, develop and the Bank may, in addition to coming in line with the policies, instruction and promote Islamic modes of banking in line with the Pakistan for promotion and "(f) promote Islamic modes of balance Bank of Pakistan for promotion of Islamic banking.".

Amendment in section 19 of N.-W.F.P. Act No. XIV of 1991 .--- In the said Act, in section 3. 19, in sub-section (1), clause (qq) shall be deleted.
