Preamble.---WHEREAS it is expedient to provide for the up-gradation of Islamia College, Peshawar to be known as the Islamia College, Peshawar, for the purposes hereinafter appearing;

It is hereby enacted as follows:-

CHAPTER-I PRELIMINARY

1. <u>Short title and commencement.</u>---(1) This Act may be called the Islamia College, Peshawar Act, 2009.

(2) It shall come into force at once.

2. <u>Definitions.</u>---In this Act. unless the context otherwise requires, the following $e_{xpressing}$ shall have the meanings hereby respectively assigned to them, that is to say.-

- (a) "Academic Council" means the Academic Council of the University;
- (b) "affiliated college" or "affiliated institution" means a college or institution affiliated to the University but not maintained or administered by it;
- (c) "Authority" means any of the Authorities of the University specified in section 18;
- (d) "College" means a constituent college or an affiliated college:
- (c) "Chairperson" means head of a Teaching Department;
- (f) "Chancellor" means the Chancellor of the University;
- (g) "Commission" means the Higher Education Commission set up by the Higher Education Commission Ordinance, 2002 (LIII of 2002):
- (h) "constituent college" or "constituent institution" means college or institution maintained and administered by the University;
- (i) "Dean" means the Dean of a Faculty;
- "Department" means a teaching department maintained and administered. or recognized by the University in the manner prescribed;
- (k) "Director" means the head of an institute established as a constituent institution by the University by Statutes or Regulations in terms of the powere delegated by this Act:
- (1) "Faculty" means an administrative and academic unit of the University consisting of one or more departments, as prescribed;
- (m) "Government" means the Government of the North-West Frontier Province;
- (n) "Institute" means a constituent institution or an affiliated institution;
- (o) "Officer" means an Officer of the University specified in this Act;
- (p) "prescribed" means prescribed by Statutes, Regulations or Rules made under this Act;
- (q) "Pro-Chancellor" means Pro-Chancellor of the University;

- "Professor Emeritus" and "Honorary Professor" means a retired Professor (r) working in a Faculty in the capacity of an Emeritus or Honorary Professor:
- "Principal" means the head of a College or school; (s)
- "Regulations". "Rules" and "Statutes" mean respectively the Regulations. (1)Rules and Statutes made under this Act:
- "Representation Committees" means a Representation Committees constituted (u) under section 26:
- "Review Panel" means the Review Panel set up by the Chancellor in (v)accordance with the provisions contained in clause (a) of sub-section (6) of section 9:
- "school" means the Islamia Collegiate School referred to in sub-section (2) of (w) section 3:
- "Search Committee" means the Search Committee set up by the Chancellor (\mathbf{x}) under sub-section (2) of section 12;
- "section" means a section of this Act; (V)
- "Syndicate" means the Syndicate of the University; (Z)
- "Schedule" means a Schedule to this Act; (aa)

(af)

- "Senate" means the Senate of the University: (ab)
- "Teachers" includes Professors, Associate Professors, Assistant Professors, Lecturers and Research staff engaged whole-time by the University for (ac) teaching degree, honors or post-graduate classes, and such other persons as may be declared to be teachers by the Statutes;
- "Teaching Department" means a constituent institution. College or Department, where teaching or research is being undertaken; (ad)
- "University" means the Islamia College, Peshawar established at Peshawar (ae) under this Act; and
- "Vice-Chancellor" means the Vice-Chancellor of the University.

CHAPTER -II THE UNIVERSITY

Incorporation .--- (1) Soon after the commencement of this Act. the Islamia College, Peshawar shall be up-graded into University to be known as Islamia College, Peshawar. 3.

(2) Islamia College for Girls and Islamia Collegiate School shall be the constituent college and constituent school of the University.

- (3) The University shall consist of:
 - (i) the Chancellor, the Pro-Chancellor, the Vice-Chancellor, the members of the Senate, the Deans, the Principals of the constituent colleges, the Directors of Institutes, the Chairperson of the Teaching Departments, the Registrar, the Controller of Examination, the Teachers and students of the University, the Librarian, the Auditor and such other officers as may be prescribed; and
 - the members of the Syndicate, the Academic Council, the Board of Faculties, constituent colleges, constituent institutions and school of the University and other Authorities of the University.

(4) The University shall be a body corporate by the name of Islamia College Peshawar having perpetual succession and a common seal and may, by the said name, suc and be sued.

(5) The University shall be competent to acquire and hold property, both movable and immovable, and to lease, sell or otherwise transfer any movable or immovable property which may have become vested in or been acquired by it.

(6) Notwithstanding anything contained in any other law for the time being in force, the University shall have academic, financial and administrative autonomy, including the powers to employ officers, teachers and other employees on such terms as may be prescribed, subject to the terms of this Act and the Higher Education Commission Ordinance, 2002 (LIII of 2002), In particular, and without prejudice to the authority granted to the Commission by the law, the Government or an authority or auditor appointed by the Government shall have no power to question the policy underlying the allocation of resources approved by the Senate in the annual budget of the University.

4. <u>Jurisdiction of the University</u>.—The University shall exercise the powers conferred on it by or under this Act within the territorial limits of the whole of the North-West Frontier Province and in North-West Frontier Province or wherever such facility exists as may apply to the University for exercise of its power:

Provided that colleges and educational institutions already affiliated with any other university immediately before the commencement of this Act, whether inside or outside its territorial jurisdiction, shall not be eligible for grant of affiliation by the University, unless the university with whom such colleges and institutions stand affiliated have no objection to the grant of such educational affiliation by the University:

Provided further that Government may, in consultation with the University, by general or special orders, modify the scope of aforesaid powers of the University with regard to the territorial limits, colleges and educational institutions.

5. <u>University open to all.</u>—The University shall be open to persons of either sex of whatever religion, race, creed, colour or domicile who are academically qualified for admission to the courses of study offered by the University, and no such person shall be denied the privileges of the University on the ground only of sex, religion, creed, caste, race, class, colour or domicile.

6. Powers of the University .--- The University shall have the powers to:

- (i) provide for education and scholarship in such branches of knowledge as it may deem fit, and to make provision for research, service to society and for the application, advancement and dissemination of knowledge in such manner as it may determine:
- (ii) prescribe courses of studies to be conducted by it and the Colleges:
- (iii) hold examinations and to award and confer degrees, diplomas, certificates and other academic distinctions to and on persons who have been admitted to and have passed its examinations under prescribed conditions;
- (iv) prescribe the terms and conditions of employment of the Officers. Teachers and other employees of the University and to lay down terms and conditions that may be different from those applicable to government servants in general;
- (v) engage, where necessary, persons on contract of specified duration and to specify the terms of each engagement;
- (vi) confer honorary degrees or other distinctions on approved persons in the manner prescribed;
- (vii) provide for such instruction for persons not being students of the University as it may prescribe, and to grant certificates and diplomas to such persons:
- (viii) institute programmes for the exchange of students and teachers between the University and other universities, educational institutions and research organizations, inside as well as outside Pakistan;
 - ix) provide career counseling and job search services to students and alumni;
- (ix) provide career counsering
- (x) maintain linkages with alumni;
- (xi) develop and implement fund-raising plans;
- (xii) provide and support the academic development of the faculty of the University;
- (xiii) confer degrees on persons who have carried on independent research under prescribed conditions;

- (xiv) affiliate and disaffiliate educational institutions under prescribed conditions:
- inspect colleges and other educational institutions affiliated or seeking (XV) affiliation with it:

(xvi) accept the examinations passed and the period of study spent by students of the University at other universities and places of learning equivalent to such examinations and periods of study in the University, as it may prescribe, and to withdraw such acceptance:

(xvii) co-operate with other universities, public authorities or private organizations, inside as well as outside Pakistan, in such manner and for such purposes as it may prescribe:

- (xviii) institute Professorships, Associate Professorships, Assistant Professorships and Lecturer ships and any other posts and to appoint persons thereto;
- create posts for research, extension, administration and other related purposes (xix) and to appoint persons thereto:
- recognize selected members of the teaching staff of affiliated colleges or (XX) educational institutions admitted to the privileges of the University or such other persons as it may deem fit, as University teachers;
- institute and award financial assistance to students in need fellowships. (xxi) scholarships, bursaries, medals and prizes under prescribed conditions;
- (xxii) establish teaching departments, schools, colleges, faculties, institutes, museums and other centers of learning for the development of teaching and research and to make such arrangements for their maintenance, management and administration as it may prescribe;
- (xxiii) provide for the residence of the students of the University and the colleges, to institute and maintain halls of residence and to approve or license hostels and
- (xxiv) maintain order, discipline and security on the campuses of the University and
- (xxv) promote the extra curricular and recreational activities of such students, and to make arrangements for promoting their health and general welfare;
- (xxvi) demand and receive such fees and other charges as it may determine;

(xxvii) make provision for research, advisory or consultancy services and with these objects to enter into arrangements with other institutions, public or private bodies, commercial and industrial enterprises under prescribed conditions;

(xxviii) enter into, carry out, vary or cancel contracts;

- (xxix) receive and manage property transferred and grants. contributions made to the University and to invest any fund representing such property, grants, bequests, trusts, gifts, donations, endowments or contributions in such manner as it may deem fit;
- (xxx) provide for the printing and publication of research and other works; and

(xxxi) to do all such other acts and things, whether incidental to the powers aforesaid or not, as may be requisite or expedient in order to further the objectives of the University as a place of education, learning, and research.

7. <u>Teaching and Examinations</u>.---(1) All recognized teaching in various courses in the University and affiliated colleges and affiliated institutions shall be conducted in the prescribed manner, and it may include lectures, tutorials, discussions, seminars, demonstrations as well as practical work in laboratories and workshops and other methods of instructions including, but not limited to, voices, graphics, text, dynamic, content, and data structures of all types whether they are in electronic, visual, auditory, optical or any other form.

(2) The teaching in any prescribed course in the University, constituent colleges or constituent institutions and affiliated colleges or affiliated institutions shall be organized by such Authority as may be prescribed.

(3) The courses and the curricula for teaching in the University and affiliated colleges or affiliated institutions shall be such as may be prescribed.

(4) A discipline to be called "Islamic and Pakistan Studies" shall be offered. as a compulsory subject at the Bachelor's level, in the University and affiliated colleges and affiliated institutions; provided that non-Muslim students may opt for "Ethics and Pakistan Studies".

(5) The University may associate external examiners for conduct of examinations as and when necessary.

(6) The degree, diploma or certificate at the University shall only be granted to a student after he has fulfilled the prescribed requirements for the said degree, diploma or certificate.

CHAPTER -III OFFICERS OF THE UNIVERSITY

8. <u>Officers of the University</u>.--- The following shall be the officers of the University, namely:

- (a) the Chancellor:
- (b) the Pro-Chancellor;
- (c) the Vice-Chancellor:
- (d) the Deans;

the Principals of the constituent colleges and school; (e)

- the Chairpersons of the teaching departments:
- (1) the Registrar: (g)
- the Directors: . (h)
- the Controller of Examinations; (i)
- the Freasurer: (j)
- the Librarian: and (k)
- such other persons as may be prescribed to be officers of the University. (1)

Chancellor and Pro-Chancellor,---(1) The Governor of the North-West Frontier Province 9. shall be the Chancellor of the University and the Chairperson of the Senate.

The Chancellor shall, when present, preside at the meetings of the Senate and the (2)Convocation of the University.

The Minister of Higher Education. Government of the North-West Frontier Province (3)shall be the Pro-Chancellor of the University and shall aid and advise the Chancellor. The Pro-Chancellor shall, in the absence of the Chancellor, preside at the Convocation of the University,

The members of the Senate as well as the Vice-Chancellor shall be appointed by the (4)Chancellor from amongst the persons recommended by the Search Committee established in accordance with this Act and the Statutes, as the case may be.

Every proposal to confer an honorary degree shall be subject to confirmation by the (5)Chancellor.

If the Chancellor is satisfied that serious irregularity or mismanagement with respect (6)to the affairs of the University has occurred, he may-

(a)

as regards proceedings of the Senate, direct that specified proceedings be reconsidered and appropriate action taken within one month of the direction

Provided that if the Chancellor is satisfied that either no reconsideration has been carried out or that the reconsideration has failed to address the concern expressed he may, after calling upon the Senate to show cause in writing, appoint a five member Review Panel to examine and report to the Chancellor on the functioning of the Senate. The report of the Revier Panel shall be submitted within such time as may be prescribed by th Chancellor. The Review Panel shall be drawn from persons of eminence has academics and in the Culture of the factor of the facto academics and in the fields of law, accountancy and administration; and

(b)

as regards proceedings of any Authority or with respect to matters within the competence of any Authority other than the Senate, direct the Senate to

(7) The Chancellor shall have the powers to assent to such Statutes as are required to be submitted to him by the Senate or withhold assent or refer them back for reconsideration.

10. <u>Removal from the Senate.</u>---(1) The Chancellor may, upon the recommendation of the Review Panel, remove any person from the membership of the Senate on the ground that such person:

- (a) has become of unsound mind; or
- (b) has become incapacitated to function as member of the Senate; or
- (c) has been convicted by a court of law for an offence involving moral turpitude:

(d) has absented himself from two consecutive meetings without just cause; or

(e) has been guilty of misconduct, including use of position for personal advantage of any kind, or gross inefficiency in the performance of functions.

(2) The Chancellor shall remove any person from the membership of the Senate on a resolution calling for the removal of such person supported by at least three-fourths of the membership of the Senate:

Provided that before passing such resolution the Senate shall provide the member concerned a fair hearing.

11. <u>Vice-Chancellor</u>.---(1) There shall be a Vice-Chancellor of the University who shall be an eminent academic or a distinguished administrator and shall be appointed on such terms and conditions as may be prescribed.

(2) The Vice-Chancellor shall be the chief executive officer of the University responsible for all administrative and academic functions of the University and for ensuring that the provisions of this Act. Statutes. Regulations and Rules are fully observed in order to promote the general efficiency and good order of the University. The Vice-Chancellor shall have all powers prescribed for this purpose, including administrative control over the officers, teachers and other employees of the University.

(3) The Vice-Chancellor shall, if present, be entitled to attend any meeting of any Authority or body of the University.

(4) The Vice-Chancellor may, in an emergency that in his opinion requires immediate action, ordinarily not in the competence of the Vice-Chancellor take such action and forward, within seventy-two hours, a report of the action taken to the members of Emergency Committee of the Senate, to be set up by the Statutes. The Emergency Committee may direct such further action as is considered appropriate.

The Vice-Chancellor shall also have the powers to: (5)

direct teachers, officers and other employees of the University to take up such direct teachers, officers and other empirication, administration and such other assignments in connection with examination, administration and such other other be may consider necessary for the may (i) assignments in connection with enay consider necessary for the purposes of the University:

sanction by re-appropriation an amount not exceeding an amount prescribed (ii) by the Senate for an unforeseen item not provided for in the budget and report it to the Senate at the next meeting;

create and fill temporary posts for a period not exceeding one year; (iii)

make appointments of such categories of employees of the University and in (iv) such manner as may be prescribed by the Statutes;

suspend, punish and remove, in accordance with prescribed procedure, from (v) service officers, teachers and other employees of the University except those appointed by or with the approval of the Senate;

- delegate, subject to such conditions as may be prescribed, any of his powers (vi) under this Act to an officer or officers of the University: and
- to exercise and perform such other powers and functions as may be prescribed. (vii)

The Vice-Chancellor shall preside at the Convocation of the University in the absence (6)of the Chancellor and the Pro-Chancellor.

The Vice-Chancellor shall present an annual report before the Senate within three (7)months of the close of the academic year. The annual report shall present such information as regards the academic year under review as may be prescribed, including disclosure of all relevant facts

- (i) academics;
- (ii) research:
- (iii) administration; and
- (iv) finances.

The Vice-Chancellor's annual report shall be made available, prior to its presentation (8)before the Senate, to all officers and University teachers and shall be published in such numbers as

Appointment and Removal of the Vice-Chancellor.---(1) The Vice-Chancellor shall be 12.

appointed by the Chancellor from a panel of three candidates proposed by the Search Committee. A Search Committee for the recommendation of persons suitable for appointment as Vice-Chancellor shall be constituted by Chancellor and shall consist of-

- (a) the Chief Secretary, Government of the North-West Frontier Province, who shall be Chairman and Convener of the Committee;
- (b) three eminent members of society, with experience in education, administration or social work;
- (c) two members of the Senate who are nominees of the Chancellor but not employees of the University; and

(d) the Secretary to Government, Higher Education Department.

(3) The members mentioned at clauses (b) and (c) of subsection (2) shall be nominated by the Chancellor while the members mentioned at clauses (a) and (d) ibid shall be members of the Search Committee by virtue of their offices.

(4) The Search Committee shall remain in existence till such time as a new Vice-Chancellor is appointed by the Chancellor.

(5) The Vice-Chancellor shall be appointed for a renewable tenure of four years on terms and conditions prescribed by Statutes. The tenure of an incumbent Vice-Chancellor shall be renewed by the Chancellor on receipt of a resolution of the Senate in support of such renewal:

Provided that the Chancellor may call upon the Senate to reconsider such resolution once.

(6) The Senate may, pursuant to resolution in this behalf passed by two-third of its membership, recommend to the Chancellor the removal of the Vice-Chancellor on the ground of inefficiency, moral turpitude or physical or mental incapacity or gross misconduct, including misuse of position for personal advantage of any kind.

(7) Where the Chancellor is of the view that the Vice-Chancellor should be removed, he may make a reference to the Senate stating the instances of inefficiency, moral turpitude or physical or mental incapacity or gross-misconduct on the part of the Vice-Chancellor that have come to his notice. After consideration of the reference the Senate may, pursuant to a resolution in this behalf passed by two-third of its membership, recommend to the Chancellor removal of the Vice-Chancellor:

Provided that prior to a resolution for the removal of the Vice-Chancellor being voted upon, the Vice-Chancellor shall be given an opportunity of being heard.

(8) A resolution recommending removal of the Vice-Chancellor shall be submitted to the Chancellor forthwith. The Chancellor may accept the recommendation and order removal of the Vice-Chancellor or return the recommendation to the Senate for reconsideration.

(9) At any time when the office of the Vice-Chancellor is vacant, or the Vice-Chancellor is absent or is unable to perform the functions of his office due to illness or some other cause, the Chancellor may appoint the senior most Dean/officer of the University to officiate as Vice-Chancellor.

Treasurer.---(1) There shall be a Treasurer of the University to be appointed by the Senale recommendation of the Vice-Chancellan on the recommendation of the Vice-Chancellor, on such terms and conditions as may be prescribed:

Provided that till such time as the Senate under this Act is fully constituted, the appointment

The Treasurer shall be the Chief Financial officer of the University and shall-(3)

- manage the assets, liabilities receipts, expenditures, funds and investments of (a) the University:
- prepare the annual and revise budget estimates of the University and present (b) them to the Syndicate or a Committee thereof for approval and incorporation in the budget to be presented to the Senate:
- ensure that the funds of the University are expended on the purposes for which (c) they are provided:
- have the account of the University audited annually so as to be available for (d) submission to the Senate within six months of the close of the financial year; and
- perform such other duties as may be prescribed. (e)

The term of office of the Treasurer shall be of three years and may be renewed from (4) time to time:

Provided that the Senate may, on the advice of the Vice-Chancellor, terminate the appointment of the Treasurer on grounds of inefficiency or misconduct in accordance with prescribed procedure.

Controller of Examinations.---(1) There shall be a Controller of Examinations to be appointed by the Senate on the recommendation of the Vice-Chancellor on such terms and conditions as may be prescribed:

Provided that till such time as the Senate under this Act is fully constituted, the appointment shall be made by the Chancellor on the recommendation of the Vice-Chancellor.

The minimum qualifications necessary for appointment to the post of the Controller of (2)Examinations shall be such as may be prescribed.

The Controller of Examinations shall be a full time officer of the University and shall be responsible for all matters connected with the conduct of examinations and perform such other duties as may be prescribed.

The term of office of the Controller of Examinations shall be three years and may be (4)renewed:

Provided that the Senate may, on the advice of the Vice-Chancellor, terminate the appointment of the Controller of Examinations on grounds of inefficiency or misconduct in accordance with prescribed procedure.

Auditor.---(1) There shall be an internal auditor of the University to be appointed by h_{e} 16. Senate on such terms and conditions as may be determined by it.

(2) The internal auditor shall be responsible for pre-auditing of all bills and documents f_{0} all payments to be made by the University.

Other Officers .--- Subject to the provisions of this Act, the terms and conditions of service . 17. and the powers and duties of other officers of the University shall be such as may be prescribed.

CHAPTER-IV AUTHORITIES OF THE UNIVERSITY

Authorities.---(1) The following shall be the Authorities of the University, namely: 18:

- such other Authorities as may be prescribed.

The Senate, the Syndicate and the Academic Council may set up such other committees or sub-committees, by whatever name described, as are considered desirable and Senate and shall consist of as the Senate, and shall consist of-

(a) the Chancellor who shall be the Chairperson of the Senate:

(b) the Vice-Chancellor;

- (c) the Secretary to Government, Higher Education Department, or his nomince not below the rank of Additional Secretary;
- (d) the Secretary to Government, Finance Department, or his nominee not below the rank of Additional Secretary;

- (f) four persons from society at large being persons of distinction in the fields of administration, management, arts, architecture, agriculture, science, technology and engineering with a view to reflecting a balance across the various fields:

Provided that the special focus or affiliation of the University. to be declared in the manner prescribed, may be reflected in the number of persons of distinction in an area of expertise relevant to the University who are appointed to the Senate;

- (g) President of the alumni of the University:
- (h) two persons from the academic community of the Province of the North-West Frontier or the country, other than an employee of the University at the level of professor or Principal of a College:
- (i) five University Teachers; and
- (i) one person nominated by the Commission.

(2) The numbers of the members of the Senate described against clauses (h). (i) and (j) of sub-section (1) may be increased by the Senate through Statutes subject to condition that the total membership of the Senate does not exceed twenty one, and the increase is balanced, to the extent possible, across the different categories specified in sub-section (1).

(3) Appointments of persons described in clauses (f) and (h) of sub-section (1) shall be made by the Chancellor from amongst a panel of three names for each vacancy recommended by the Representation Committee set up in terms of section 26 and in accordance with procedure as may be prescribed:

Provided that effort shall be made, without compromising on quality or qualification, to give fair representation to women on the Senate:

Provided further that the Senate may alternatively prescribe that appointment of University Provided further that the Senate may alternatively vided by this sub-section for the persons Teachers to the Senate shall also be in the manner provided by this sub-section for the persons described in clauses (f) and (h) of sub-section (1).

The Senate shall meet twice in a calendar year. (5)

In the absence of the Chancellor meetings of the Senate shall be presided over by such (6)member, not being employee of the University or Government, as the Chancellor may, from time to time, nominate. The member so nominated shall be the Convener of the Senate.

Unless otherwise prescribed by this Act, all decisions of the Senate shall be taken on (7) the basis of the opinion of a majority of the members present. In the event of the members being evenly divided on any matter, the person presiding over the meeting shall have a casting vote.

The quorum for a meeting of the Senate shall be two-third of its membership, a (8)fraction being counted as one.

Powers and functions of the Senate, --- (1) The Senate shall have the power of general supervision over the University and shall hold the Vice-Chancellor and the Authorities accountable for all the functions of the University. The Senate shall have all powers of the University not expressly vested in an Authority or Officer by this Act and all other powers of the Oniversity mentioned in this Act that are necessary for the performance of its functions.

Provided that the Senate may frame a Statute or Regulation on its own initiative and approve it after calling for the advice of the Syndicate or the Academic Council as the case may be;

The Chancellor shall communicate the Senate his views with regards to the results of such inspection or inquiry and shall, after ascertaining the views thereon of the Senate, advise the Senate on action to be taken.

The Senate shall communicate to the Chancellor such action, if any, as has been taken (4)or may propose action to be taken upon the results of the inspection or inquiry.

- (e) invest any money belonging to the University including any unapplied income in any of the securities described in section 20 of the Trusts Act, 1882 (Act II of 1882), or in the purchase of immovable property or in such other manner, as it may prescribe, with the like power of varying such investments;
- (f) receive and manage any property transferred, and grants, bequests, trust, gifts, donations, endowments, and other contributions made to the University;
- (g) administer any funds placed at the disposal of the University for specified purposes;
- (h) provide the buildings, libraries, premises, furniture, apparatus, equipment and other means required for carrying out the affairs of the University;

- establish and maintain halls of residence and hostels or approve or license hostels lodgings or lodgings for the residence of students; (i)
- recommend to the Senate affiliation or disaffiliation of colleges; (j)
- arrange for the inspection of Colleges and the Departments; (k)
- institute Professorships, Associate Professorships, Assistant Professorships, (1)Lecturerships, and other teaching posts or to suspend or abolish such posts;
- create, suspend or abolish such administrative or other posts as may be (m) necessary:
- prescribe the duties of officers, teachers and other employees of the (n) University:
- report to the Senate on matters with respect to which it has been asked to (0)report:
- appoint members to various Authorities in accordance with the provisions of (p) this Act:
- propose drafts of Statues for submission to the Senate; (q)
- regulate the conduct and discipline of the students of the University; (r)
- take actions necessary for the good administration of the University in general (s) and to this end exercise such powers as are necessary;
- delegate any of its powers to any Authority or officer or a committee; and (1)
- (u) perform such other functions as have been assigned to it by the provisions of this Act or the Statutes made thereunder.

Academic Council.--(1) There shall be an Academic Council of the University consisting of 24. the following:

- the Vice-Chancellor who shall be its Chairperson; (a)
- (b)
- the Deans of Faculties and all Heads of Departments and all Professors; (c)
- the Directors of Advance Studies, Research and Technological Development; five members representing the Departments, institutes and constituent colleges (d)

to be elected in the manner prescribed by the Senate; two Principals of affiliated colleges, one each from public and private (e)

- (f) five Professors including Emeritus Professors;
- (g) the Registrar;
- (h) the Controller of Examinations; and
- (i) the Librarian.

(2) The Senate shall appoint the members of the Academic Council, other than the exofficio members, on the recommendation of the Vice-Chancellor:

Provided that as regards the five professors and the members representing the departments, institutes and the constituent colleges, the Senate may, as an alternative to elections, prescribe a procedure for proposal of a penal of names by the Representation Committee set up in terms of section 26. Appointment of persons proposed by the Representation Committee may be made by the Senate on the recommendation of the Vice-Chancellor.

- (3) Members of the Academic Council shall hold office for three years.
- (4) The Academic Council shall meet at least once in six months.

(5) The quorum for meetings of the Academic Council shall be two-thirds of the total number of members, a fraction being counted as one.

25. <u>Powers and duties of the Academic Council.</u>---(1) The Academic Council shall be the Principal academic body of the University and shall, subject to the provisions of this Act and the Statutes, have the powers to lay down proper standards of instruction, research and examinations and to regulate and promote the academic life of the University and the Colleges/Institutes.

- recommend to the Syndicate schemes for the constitution and organization of (c) . Faculties, Teaching Departments and Boards of Studies;
- appoint paper setters and examiners for all examinations of the University (d) after receiving panels of names from the relevant authorities;
- institute programmes for the continued professional development of (e) University Teachers at all levels:
- recognize the examinations of other universities or examining bodies as (f) equivalent to the corresponding examinations of the University;
- regulate the award of studentships, scholarships, exhibitions, medals and (g) prizes;
- propose, from time to time, Regulations to the Senate on the recommendations (h) of the Board of Faculties and the Board of Studies, prescribing the courses of studies, the syllabi and examinations:

Provided that if the recommendations of the Board of a Faculty or Board of Studies are not received by the prescribed date, the Academic Council may, subject to the approval of the Senate, permit the existing Regulations to continue for the following year:

(7) There may also be such other Representation Committees set up by any of the other Authorities of the University as are considered appropriate for recommending persons for appointment to the various Authorities and other bodies of the University.

27. <u>Constitution, function and powers of other Authorities.</u>—The constitution, functions and powers of other Authorities for which no specific provisions, or insufficient provisions, have been made in this Act shall be such as may be prescribed by the Statutes.

28. <u>Appointment of Committees by certain Authorities</u>.---(1) The Senate, the Syndicate, the Academic Council and other Authorities may, from time to time, appoint such standing, special or advisory committees, as they may deem fit, and may place on such committee persons who are not members of the Authorities appointing the Committees.

(2) The constitution, functions and powers of the Authorities for which no specific provision has been made in this Act shall be such as may be prescribed by Statutes or Regulations.

CHAPTER -V STATUTES, REGULATIONS AND RULES

29. <u>Statutes.</u>---(1) Subject to the provisions of this Act, Statutes may be made to regulate or prescribe all or any of the following matters, namely:

- (a) the contents of and the manner in which the annual report to be presented by the Vice-Chancellor before the Senate;
- (b) the University fees and other charges;
- (c) the constitution of any pension, insurance, gratuity, provident fund and benevolent fund for University employees;

- the scales of pay and other terms and conditions of service of officers, teacher (d)and other University employees;
- the maintenance of the register of registered graduates; (e)
- affiliation and disaffiliation of educational institutions and related matters; (f)
- admission of educational institutions to the privileges of the University and the (g) withdrawal of such privileges;
- the establishment of Faculties, Departments, institutes: colleges and other (h) Academic Divisions:
- the powers and duties of Officers and Teachers; (i)
- conditions under which the University may enter into arrangements with other (i) institutions or with public bodies for purposes of research and advisony services:
- conditions for appointment of Emeritus Professors and award of honorary (k) degrees:
- efficiency and discipline of University employees; (1)
- procedure to be followed by Representation Committees in carrying out (m) functions in terms of this Act;
- constitution, functions and powers of the Authorities of the University; and (n)
- (0)all other matters which by this Act are to be or may be prescribed or regulated

The draft of Statutes shall be proposed by the Syndicate to the Senate which may (2)approve or pass with such modifications as the Senate may think fit or may refer back to the Syndicate, as the case may be, for reconsideration of the proposed draft:

Provided that Statutes concerning any of the matters mentioned in clauses (a) and (1) of subsection (1) shall be initiated and approved by the Senate, after seeking the views of the Syndicate:

Provided further that the Senate may initiate a Statute with respect to any matter in its power or with respect to which a Statute may be framed in terms of this Act and approve such Statute after

Regulations.---(1) Subject to the provisions of this Act and the Statutes, the Academic 30.

Council may make Regulations, for all or any of the following matters, namely: the courses of study for degrees, diplomas and certificates of the University;

- the manner in which the Teaching referred to in sub-section (1) of section 7 (b) shall be organized and conducted:
- the admission and expulsion of students to and from the University; (C)
- the conditions under which students shall be admitted to the courses and the (d)examinations of the University and shall become eligible for the award of degrees. diplomas and certificates:
- the conduct of examinations; (e)
- conditions under which a person may carry on independent research to entitle (f) him to a degree:
- the institution of fellowships, scholarships, exhibitions, medals and prizes; (g)
- the use of the Library: (h)
- the formation of Faculties. Departments and Board of Studies; and (i)
- all other matters which by this Act or the Statutes made there under are to be. (j) or may be prescribed by Regulations.

Regulations shall be proposed by the Academic Council and shall be submitted to the Senate which may approve them or withhold approval or refer them back to the Academic Council for reconsideration. A Regulation proposed by the Academic Council shall not be effective unless it receives the approval of the Syndicate.

(3) Regulations regarding or incidental to matters contained in clauses (g) and (i) of subsection (1) shall not be submitted to the Senate without the prior approval of the Syndicate.

Amendment and repeal of Statutes and Regulations .--- The procedure for adding to. amending or repealing the Statutes and the Regulations shall be the same as that prescribed 31. respectively for framing or making Statutes and Regulations.

Rules.---(1) The Authorities and the other bodies of the University may make rules, consistent with this Act. Statutes or the Regulations, to regulate any matter relating to the affairs of the University for which detailed provisions have been provided for by this Act or which is not required to be regulated by Statutes or Regulations, including rules to regulate the conduct of business and the time and places of meetings and related matters.

Rules shall become effective upon approval by the Syndicate. (2)

Affiliation of educational institution.---(1) An educational institution seeking affiliation to 33.

- the educational institution has a provision for a library and adequate library (g) · services:
- the educational institution has properly equipped laboratories, museums and (h)other places of practical work required for courses of studies taught thereim
- the educational institution has or can make provisions for residence of its Head (i) and other members of the teaching staff.

The application shall further contain an undertaking by educational institution that (2)after it is affiliated, any changes in management or teaching staff shall forthwith be reported to the University and that the teaching staff shall possess such qualification as are, or may be, prescribed:

Provided that ownership of the affiliated institution shall not be transferred to any new owner without prior approval of the University.

The Syndicate shall after considering the recommendations of the Affiliation (3)Committee, dispose off the application for affiliation in accordance with such procedure as may be prescribed and may grant or refuse affiliation; provided that affiliation shall not be refused, unless the advertional institution has been given in accordance with such procedure as the the educational institution has been given an opportunity of making a representation against the

Extension of Affiliation.---When an affiliated college desires to add to the courses of studies in respect of which it is granted affiliation, the procedure prescribed for affiliation of college shall. as

35. <u>Inspection and Reports</u>.--(1) Every affiliated educational institution shall furnish such reports, returns and other information as the University may require to enable it to judge the efficiency of the educational institutions.

(2) The University may call upon any affiliated educational institution to take, within a specified period, such action in respect of any matter mentioned in sub-section (1) as the University may deem fit.

36. **Disaffiliation.**---(1) If an educational institution affiliated to the University has failed to fulfil any requirement of this Act or has failed to observe any of the conditions of affiliation or its affairs are conducted in a manner prejudicial to the interest of education, the Syndicate may, in the prescribed manner, and after considering any representation that the educational institution may wish to make, modify or withdraw all or any of the privileges conferred on the educational institution by the affiliation.

(2) Where all or any of the privileges conferred on any educational institution by affiliation have been modified or withdrawn under sub-section (1), it may, within the prescribed period, apply for review to the Syndicate against such refusal and the application shall be disposed of in such manner as may be prescribed.

CHAPTER -VI UNIVERSITY FUND

37. <u>University Fund.</u>—There shall be a Fund of the University to be called the University Fund to which shall be credited all money received by it from fees, donations, trusts, bequests, endowments, contributions, grants and other sources.

38. <u>Recovery of University Dues.</u>—All dues of the University shall be recoverable as arrears of land revenue.

39. <u>Audits and accounts.</u>---(1) The Accounts of the University shall be maintained and audited in such form and in such manner as may be prescribed.

(2) All funds generated by a Teaching Department, constituent colleges or other unit of the University through consultancy, research or other provision of service shall be credited to the University fund:

Provided that the Teaching Department, constituent college or other unit concerned may be allowed enhanced budget allocation equivalent to a part of the funds generated in accordance with prescribed terms and procedure.

(3) No expenditure shall be made from the funds of the University, unless a bill for its payments has been audited in accordance with the Statutes and the Treasurer has verified that the payment is provided for in the approved budget.

(4) Provision shall be made for an internal audit of the finances of the University.

44. <u>Benefits and Insurance</u>.---(1) The University shall constitute for the benefit of its Officers. Teachers and other employees schemes, as may be prescribed, for the provision of post-employment benefits as well as health and life insurance while in service.

(2) Where any provident fund has been constituted under this Act. the provisions of the Provident Fund Act. 1925 (XIX of 1925), shall apply to such funds as if it were the Government Provident Fund:

45. <u>Commencement of Term of Office of Members of Authority</u>.---(1) When a member of a newly constituted Authority is elected, appointed or nominated, his term of office, as fixed under this Act, shall commence with immediate effect.

48. <u>Proceedings of Authorities not invalidated by the vacancies.</u>---No act, resolution or decision of any Authority shall be invalid by reason of any vacancy on the Authority doing, passing, or making it or by reason of any want of qualification or invalidity in the election, appointment or nomination of any de-facto member of the Authority, whether present or absent.

49. <u>First Statutes.</u>---Notwithstanding anything to the contrary contained in this Act, the Statutes, set out in the Schedule appended to this Act shall be deemed to be the Statutes framed under section 29 of this Act and shall continue to remain in force until amended or repealed.

50. <u>Removal of Difficulties</u>.---(1) If any question arises as to the interpretation of any of the provisions of this Act, it shall be placed before the Chancellor whose decision thereon shall be final.

Power to acquire Officers, Teachers or employees to serve under Government or any 53. other Organization .--- (1) Notwithstanding anything contained in this Act:

5. <u>Teaching Department/Institute and Chairperson/Director</u>.---(1) There shall be a Teaching Department / Institute for each subject or a group of subjects. as may be prescribed by Regulations and each Teaching Department/ Institute shall be headed by a Chairperson / Director.

(2) The Chairperson of a Teaching Department/Director of an institute shall be appointed by the Syndicate on the recommendations of the Vice-Chancellor from amongst the three senior most Professors of the Department/Institute for a period of three years and shall be eligible for reappointment:

Provided that in a Department / Institute where there are less than three Professors, the appointment shall be made from amongst the three senior most Professors, and Associate Professors of the Department/Institute:

Provided further that in a Department / Institute in which there is no Professor or Associate Professor, no such appointments shall be made and the Department / Institute shall be looked after by the Dean of the Faculty with the assistance of the senior most Teacher of the Department / Institute.

(3) The Chairperson of Department/Director of the Institute shall plan, organize and supervise the work of the Department/Institute and shall be responsible to the Dean for the work of his Department/Institute.
