The North-West Frontier Province Civil Courts Amendment) Bill. 2009 having been passed by the Provincial Assembly of North-West Frontier Province on 21st January. 2009 and assented to by the Governor of the North-West Frontier Province in 29th January . 2009 is hereby published as an Act of the Provincial Legislature of the North-West Prontier Province.

AN ACT

further to amend the West Pakistan Civil Courts Ordinance, 1962.

Preamble.---WHEREAS it is expedient further to amend the West Pakistan Civil Courts Ordinance, 1962 (W.P. Ord. No. II of 1962). for the purpose hereinafter appearing;

It is hereby enacted as follows:-

1. <u>Short title and commencement.</u>--- (1) This Act may be called the North-West Frontier Province Civil Courts (Amendment) Act, 2009.

(2) It shall come into force at once.

2. <u>Amendment of section 18 of W.P. Ord. No. II of 1962</u>.--- In the West Pakistan Civil Ordinance, 1962 (W.P. Ord. No. II of 1962), in section 18, after sub-section (1), the $foll_{0W_{ib}}$ sub-section shall be inserted, namely:

"(1A) Subject to the provisions of section 102 of the Code of Civil Procedure, no second appeal shall lie in any other suit when the amount or value of the su matter of the original suit does not exceed five hundred thousand rupees."

3. **Repeal.-** The North-West Frontier Province Civil Courts (Amendment) Ordinance (N.-W.F.P. Ordinance No. XXII of 2008) is hereby repealed.
