It is hereby enacted as follows:

• <u>Short title and commencement.</u>---(1) This Act may be called the North-West Frontier •ovince Establishment of a Commission on the Status of Women Act, 2009.

(2) It shall come into force at once.

Definitions .--- In this Act, unless there is anything repugnant to the subject or context,-

- (a) "Chairperson" means the Chairperson of the Commission or a District Committee, as the case may be;
- (b) "Commission" means the Provincial Commission on the Status of Women established under section 3:
- (c) "Department" means the Government of the North-West Frontier Province, Zakat, Ushr, Social Welfare and Women Development Department;
- (d) "District Committee" means a District Committee on the Status of Women, constituted under section 17:
- (e) "Government" means the Government of the North-West Frontier Province:
- (f) "member" means the member of the Commission or a District Committee, as the case may be:
- (g) "prescribed" means prescribed by rules: and
- (h) "Secretary" means the Secretary of the Commission or a District Committee. as the case may be.

Establishment of the Commission.---(1) Soon after the commencement of this Act. vernment shall, by notification in the official Gazette, establish a Commission on the Status of omen.

(2) The Commission shall consist of not less than nine and more than fifteen female mbers including a Chairperson.

(2A) The Chairperson and members shall be persons of integrity, good standing and repute ing the knowledge of laws related to women; and fully apprehend social, economic and legal oblems faced by women.

(3) The Chairperson and the members shall be appointed by the Government with ference given to female members of the Provincial Assembly of NWFP.

<u>Terms of office and conditions of service of the Chairperson and Members.</u>---(1) The airperson and members shall hold office for a period of three years on such terms and conditions

Secretariat of the Commission .--- (1) The Department shall be the Secretariat of the mmission.

Functions of the Commission.--- The Commission shall.-

 - review all provincial laws, rules and regulations affecting the status and rights of women and suggest repeal, amendments or new legislations essential to eliminate discrimination, safeguard and promote the interests of women and (b) achieve gender equality in accordance with the Constitution of the Islamic Republic Republic of Pakistan, 1973 and obligations under International Covenants and

Meetings of the Commission .--- (1) Meetings of the Commission shall be held at its 8. Secretariat, at least once in a month.

The meeting of the Commission shall be conducted in accordance with the procedure as may be prescribed and until such procedure is prescribed in such manner as the Minister for Social (2)Welfare, NWFP may direct.

The powers and functions of the Chairperson shall, in his absence, be exercised and (3)performed by the senior most member of the Commission by appointment.

The quorum to constitute a meeting of the Commission shall be one-third of its total (4)membership.

(4A) A member of the Commission who willfully fails to attend two consecutive meetings shall stand terminated from the membership of the Commission.

(5) All orders and decisions of the Commission shall be authenticated by the signature of the Chairperson or any person authorized in this behalf by Chairperson.

No act or proceedings of the Commission shall be invalid on the ground, merely of (6) the existence of any vacancy in, or defect in the constitution of the Commission. -

Appointments of Committee .--- The Commission may, in consultation with the Government, 9. appoint such committees, consisting of such of its members as it may think fit and may refer to them any matter for consideration and report.

Appointment of Advisors etc .--- The Commission may with the approval of Government. 10. appoint advisors, consultants and experts, having specialization and expertise in women related fields and problems, on such terms and conditions as may be prescribed.

Commission Fund.---(1) There shall be established by the Government a Fund to be known 11. as the Commission on the Status of Women Fund, hereinafter referred to as "Commission Fund", which shall consist of:

Budget.---(1) The Department shall prepare budget for the next financial year in respect of 12. Commission.

The Commission shall furnish to Department within four months of the close of the financial year, an audited statement in the prescribed form and a complete report on the working of he Commission during the year, and copies of the said statement account and report shall also be published in the Official Gazette.

Financial Control.--- The Secretary of Commission shall be the Principal Accounting Officer of the Commission in respect of the expenditures incurred against the budget grant or grants made to the Commission Fund and shall, for this purpose, exercise all the financial and administrative powers delegated to the Secretary of Commission by Government.

Audit and Accounts.--- The Accounts of the Commission shall be maintained and audited in 14.

Two of these members shall be from amongst the elected Members of the Zilla members. Council, who shall be recommended by the Zilla Nazim. Executive District Officers of the Health. Education, Planning and Finance Departments shall be the ex-officio Members of a District Committee. Majority of the Members shall be women, and at least one woman from the minorities in the districts where minorities account for at least ten per cent of the total population.

(4) The Chairperson and the members shall be appointed by Government.

Term and condition of service of the Chairperson and members of a District Committee.---(1) The Chairperson and members of a District Committee shall hold office for a period of three years on such terms and conditions, as may be prescribed by Government and shall be eligible for reappointment for a similar term or such shorter term as the Government may determine.

Removal of Chairperson or member of District Committee .--- (1) Government may remove, the Chairperson or a member of a District Committee, if he has,-19.

Secretariat of District Committee .--- (1) The office of the Social Welfare at each district 20. level shall be the Secretariat of a District Committee.

The District Officer, Social Welfare and Women Development shall act as Secretary (2)of a District Committee.

The meetings of a District Committee shall be conducted in accordance with the atedure as may be prescribed and until such procedure is prescribed, in such manner as the himerson may direct.

The powers and functions of the Chairperson shall, in his absence, be exercised and (3)alormed by such a Member as Chairperson may appoint.

The quorum to constitute a meeting of a District Committee shall be two-third of its (4) al membership.

All orders and decisions of a District Committee shall be authenticated by the guature of the Chairperson or any person authorized in this behalf by Chairperson.

No act or proceedings of a District Committee shall be invalid on the ground, merely the existence of any vacancy in, or defect in the constitution of the District Committee.

Financial Control.---(1) The Chairperson of a District Committee shall be the Principal Accounting Officer of a District Committee in respect of the expenditure incurred against budget, grant or grants made to the District Committee Fund and shall, for this purpose, exercise all the financial and administrative powers delegated to him by Government.

A District Committee shall, in consultation with Government and authorities of the (2)Local Fund Audit, appoint a qualified Auditor, who shall carry out the internal audit of the accounts of a District Committee.

The Auditor referred to in sub-section (2) shall be appointed on such remuneration (3)and on such terms and conditions as Chairperson may determine.

Assistance to District Committees .--- All executive authorities in the districts shall assist the 26. District Committees, in the performance of its functions.

Executive Body .--- There shall be an executive Body of a District Committee consisting of 27. the Chairperson, Secretary and three other members to be elected by a District Committee, which shall be responsible for overseeing the implementation of decisions and recommendations of a District Committee.

Chairperson, members and other staff of the Commission and District Committee, to be 28. public servants .--- The Chairperson, members, officers and other employees of the Commission and a District Committees shall be deemed to be public servants within the meaning of section 21 of the Pakistan Penal Code, 1860 (Act XLV of 1860).

Reports .--- (1) The Commission and a District Committee shall prepare annual report of its 29. activities and such other periodical or special reports as it may consider necessary.

Reports of the Commission shall be submitted to the Chief Minister, North-West (2)Frontier Province and laid before the Provincial Assembly.
