The North-West Frontier Province Land Laws (Second Amendment) Bill. 2009 having been passed by the Provincial Assembly of North-West Frontier Province on 21st January. 2009 and assented to by the Governor of the North-West Frontier Province on 29th January . 2009 is hereby published as an Act of the Provincial Legislature of the North-West Frontier Province.

THE NORTH-WEST FRONTIER PROVINCE LAND LAWS (SECOND AMENDMENT) ACT; 2009.

(N-W.F.P. ACT NO. HI OF 2009)

(First published after having received the assent of the Governor of the North-West Frontier Province in the Gazette of the N.-W.F.P. (Extraordinary), Dated the 4th February, 2009).

AN ACT

to repeal the North-West Frontier Province Land Laws (Amendment) Ordinance, 2008 and further to amend certain land laws.

Preamble.---WHEREAS it is expedient to repeal the North-West Frontier Province Land Laws (Amendment) Ordinance. 2008 (N.-W.F.P. Ord. No. XV of 2008), and further to amend certain land laws:

It is hereby enacted as follows:-

Short title and commencement.--- (1) This Act may be called the North-West Frontie Province Land-Laws (Second Amendment) Act, 2009,

It shall come into force at once and shall be deemed to have taken effect on the (2)October, 2008.

Repeal of N.-W.F.P. Ord. No. XV of 2008.--- The North-West Frontier Province Land Law 2. <u>Repeat of N.-W.F.P. Ord. (W.F.P. Ord. No. XV of 2008) is hereby repeated and shalls</u> (Amendment) Ordinance, 2008 (N.-W.F.P. Ord. No. XV of 2008) is hereby repeated and shalls (Amendment) Ordinance. 2006 (iv. 1111 for the order of th force.

Amendment of certain land laws .--- The laws specified in column 3 of the Schedul 3. appended to this Act shall be amended to the extent and in the manner specified against each column 4 of the said Schedule.

Repeal.- The North-West Frontier Province Land Laws (Second Amendment) Ordinance 4. 2008 (N-W.F.P. Ordinance No. XX of 2008) is hereby repealed.

For section 5, the following shall be substituted namely:

"5. Province to be divided into Divisions, There shall be as many Divisions in the Province, with such limits and such areas, a Government may, by notification, direct."

For section 6. the following shall be substituted namely:

"6. Divisions to be divided into District and Districts into Sub-Divisions, etc .--- (Each Division shall be divided into such Districts and each District may be divided into such Sub-Divisions or Tchsils as Government may by notification specify and each Sub-Division may consist of such Tehsils and Sub-Tehsils and having such limits. as Government may by notification, direct.

(2) Government may by notification vary the number and limits of Divisions, Districts, Sub-Divisions. Tchsils and Sub-Tchsils in the Province.".

In section 7 -

(i) in sub-section (1), after clause (c), the following new clause shall be inserted namely:

> Assistant Commissioner;": and "(cc)

- after sub-section (2), the following new (ii) sub-section shall be added namely:
 - "(3) The Assistant Commissioner shall be the incharge of the Sub-Division of the District.".

For section 8, the following shall be substituted namely:

"8. Appointment of Commissioner and Collector .--- For each Division there shall be a Commissioner and in each District there shall be a Collector, who shall be appointed by Government. and who shall exercise throughout the Division or District as the case may be, all the powers, and discharge all the duties of the Commissioner or Collector, as the case may be, under this Act.".

5. For section 9, the following shall be substituted, namely:

"9. <u>Appointment of Additional Commissioners</u> and <u>Additional Collectors.</u>-- Government may appoint in any Division one or more Additional Commissioners or in any District one or more Additional Collectors. who shall exercise throughout the Division or District concerned all or any of the powers and discharge all or any of the duties conferred or imposed on a Commissioner or Collectors as the case may, by or under this Act. subject to the general supervision and control of the Commissioner of the Division.".

6. Section 18A shall be deleted.

7. In sections 7, 13, 14, 16, 60, 63, 69, 84, 89, 92, 101, 102, 103, 104, 107 and 108, for the words "District Officer (Revenue and Estate)", wherever occurring, the word "Commissioner" shall be substituted.

8. In sections 161, 162, 163 and 164, for the words "Revenue Appellate Court", wherever occurring, the word "Commissioner" shall be substituted.".
