Dated Peshawar, the 4th February, 2009.

No. PA/NWFP/Bills/2009/4050.—The North-West Frontier Province Salaries, Allowances and Privileges Laws (Amendment) Bill, 2009 having been passed by the Provincial Assembly of North-West Frontier Province on 21st January, 2009 and assented to by the Governor of the North-West Frontier Province on 29th January, 2009 is hereby published as an Act of the Provincial Legislature of the North-West Frontier Province.

### THE NORTH-WEST FRONTIER PROVINCE SALARIES, ALLOWANCES AND PRIVILEGES LAWS (AMENDMENT) ACT, 2009.

(N.-W.F.P. ACT NO. IV OF 2009)

*(First published after having received the assent of the Governor of the  
North-West Frontier Province in the Gazette of the N.-W.F.P.  
(Extraordinary), dated the 4th February, 2009.*

#### AN ACT

*further to amend the laws relating to the Salaries and Allowances of the Members  
of the Provincial Assembly of the North-West Frontier Province and Salaries,  
Allowances and Privileges of the Speaker and Deputy Speaker of the  
North-West Frontier Province.*

**Preamble.**— WHEREAS it is expedient further to amend the Provincial Assembly of the North-West Frontier Province (Salaries and Allowances of Members) Act, 1974 (N.-W.F.P. Act No. XI of 1974) and the North-West Frontier Province Speaker and Deputy Speaker's (Salaries, Allowances and Privileges) Act, 1975 (N.-W.F.P. Act No. III of 1975), for the purposes hereinafter appearing;

It is hereby enacted as follows:

1. **Short title and commencement.**— (1) This Act may be called the North-West Frontier Province Salaries, Allowances and Privileges Laws (Amendment) Act, 2009.

(2) It shall come into force at once.

2. **Amendment of certain laws.**— The laws specified in column 3 of the Schedule appended to this Act shall be amended to the extent and in the manner specified against each in column 4 of said Schedule.

			<p>3. In section 7, in the first proviso, for the word "four", the word "five" shall be substituted.</p> <p>4. In section 7-A, for the word "four", the word "ten" shall be substituted.</p> <p>5. After section 7-B, the following new section 7-C shall be inserted, namely:</p> <p><b>"7C. Utility Allowance.</b>— A Member shall be entitled to receive utility allowance at the rate of three thousand rupees per month."</p> <p>6. In section 10, for the words "six hundred and fifty", the words "one thousand" shall be substituted.</p>

In section 3, for the words "twenty thousand two hundred and fifty rupees", the words "thirty thousand and five hundred rupees" shall be substituted.</p> <p>2. In section 5, for the words "six thousand rupees", the words "eight thousand rupees" shall be substituted.</p> <p>3. For section 6, the following shall be substituted, namely:</p> <p><b>"6. Equipment allowances of the Speaker.</b>— The Speaker on appointment shall receive equipment allowance of five thousand rupees, once for tenure of the Assembly."</p> <p>4. After section 6, the following new section 6A shall be added, namely:</p> <p><b>"6A Discretionary grant.</b>—A sum of rupees five hundred thousand per annum shall be placed at the disposal of the Speaker for making discretionary grants in such manner as may be prescribed."</p> <p>5. Telephone.</b>—The Speaker shall be entitled at Government expense, to the use of one telephone at his office and one telephone</p>

			<p>at his residence both for official and unofficial use throughout the term of his office. In addition to the above the Speaker shall also be entitled to the use of one cellular phone with a bill not exceeding rupees two thousand per month.”.</p> <p>6. In section 8, in sub-section (1), in clause (i), for the words “Economy class”, the words “first or business class” shall be substituted.</p> <p>7. In section 9, in sub-section (1), in clause (a), for sub-clauses (i) and (ii), the following shall respectively be substituted, namely:</p> <p>“(i) an ordinary first class tourist car; or</p> <p>(ii) two berthed Air-conditioned first class.”.</p> <p>8. In section 11, in clause (a), for the word “two”, the word “three” shall be substituted.</p> <p>9. In section 12, in sub-section (1), for the words “three hundred thousand”, the words “five hundred thousand” shall be substituted.</p> <p>10. In section 13, for the words “four hundred and fifty rupees per day”, the words “one thousand rupees per day” shall be substituted.</p> <p>11. In section 18, for the words “eighteen thousand rupees”, the words “twenty-seven thousand rupees” shall be substituted.</p> <p>12. After section 19-A, the following new section 19-B and 19-C shall be added, namely:</p> <p><b>“19-B. <u>Equipment allowance of the Deputy Speaker.</u></b>—The Deputy Speaker on appointment shall receive equipment allowance of three thousand rupees once for the tenure of the Assembly.</p> <p><b>“19-C. <u>Discretionary grant.</u></b>—A sum of rupees three hundred thousand per annum shall be placed at the disposal of the Deputy Speaker for making discretionary grants in such manner as may be prescribed.”.</p>

			<p>13. In section 20, in sub-sections (3) and (4), for the words "sixteen thousand rupees", the words "thirty-five thousand rupees" shall be substituted.</p> <p>14. After section 20, the following new section 20A shall be added, namely:</p> <p><b>"20A. Telephone.</b>—The Deputy Speaker shall be entitled at Government expense, to the use of one telephone at his office and one telephone at his residence both for official and unofficial use throughout the term of his office. In addition to the above the Deputy Speaker shall also be entitled to the use of one cellular phone with a bill not exceeding rupees two thousand per month."</p> <p>15. In section 21, in sub-section (1), in sub-clause (i), for the words "economy class", the words "first or business class" shall be substituted.</p> <p>16. In section 24, in clause (a), for the words "one rupee and twenty paisa", the words "three rupees" shall be substituted.</p> <p>17. In section 24A, in sub-section (1), for the words "three hundred thousand", the words "five hundred thousand" shall be substituted.</p> <p>18. In section 25, for the words "four hundred and fifty per day", the words "seven hundred and fifty per day" shall be substituted."</p>
