#### NOTIFICATION

Dated Peshawar, the 24th October, 2009.

No.PA/NWFP/Bills/2009/38467.—The North-West Frontier Province Urban Immovable Property Tax (Amendment) Bill, 2009 having been passed by the Provincial Assembly of North-West Frontier Province on 14th October, 2009 and assented to by the Governor of the North-West Frontier Province on 20th October, 2009 is hereby published as an Act of the Provincial Legislature of the North-West Frontier Province.

## THE NORTH-WEST FRONTIER PROVINCE URBAN IMMOVABLE PROPERTY TAX (AMENDMENT) ACT, 2009.

(N-W.F.P. ACT NO. XV OF 2009)

(First published after having received the assent of the Governor of the North-West Frontier Province in the Gazette of the N.-W.F.P. (Extraordinary), Dated the 24th October, 2009).

AN ACT

further to amend the West Pakistan Urban Immovable Property Tax Act, 1958.

Preamble.--- WHEREAS it is expedient further to amend the West Pakistan Urban Immovable Property Tax Act. 1958 (W.P. Act No. V of 1958), for the purpose hereinafter appearing;

. It is hereby enacted as follows:-

- 1. Short title and commencement.---(1) This Act may be called the North-West Frontier Province Urban Immovable Property Tax (Amendment) Act, 2009.
  - (2) It shall come into force at once.
- 2. <u>Amendment of section 4 of W.P. Act No. V of 1958.</u>—In the West Pakistan Urban Immovable Property Tax Act, 1958 (W.P. Act No. V of 1958), in section 4, in clause (c), in the second proviso, for the word "further", the word "also" shall be substituted and before the second proviso as so amended, the following new proviso shall be inserted, namely:

"Provided further that the owner of such residential buildings shall not be liable to pay arrears of the tax, if any, for a period falling before the 1<sup>st</sup> day of July, 2004:".

3. <u>Repeal.</u>- The North-West Frontier Province Urban Immovable Property Tax (Amendment) Ordinance, 2009 (N.W.F.P. Ordinance No. VI of 2009), is hereby repealed.
