further to amend the West Pakistan Urban Immovable Property Tax Act, 1958.

Preamble.--- WHEREAS it is expedient further to amend the West Pakistan Urban Immovable Property Tax Act. 1958 (W.P. Act No. V of 1958), for the purpose hereinafter appearing;

Short title and commencement.---(1) This Act may be called the North-West Frontier Province Urban Immovable Property Tax (Amendment) Act, 2009.

It shall come into force at once. (2)

"Provided further that the owner of such residential buildings shall not be liable to pay arrears of the tax, if any, for a period falling before the 1st day of July, 2004:".

Repeal.- The North-West Frontier Province Urban Immovable Property Tax (Amendment) 3. Ordinance, 2009 (N.W.F.P. Ordinance No. VI of 2009), is hereby repealed.
