ACT further to amend the Provincial Motor Vehicles Ordinance, 1965.

Preamble .--- WHEREAS it is expedient further to amend the Provincial Motor Vehicles Ordinance, 1965 (W.P. Ord. No. XIX of 1965), for the purposes hereinafter appearing;

It is hereby enacted as follows:-

Short title and commencement.--- (1) This Act may be called the Provincial Motor Vehicles (North-West Frontier Province) (Amendment) Act, 2009.

It shall come into force at once. (2)
