



ACT**

further to amend the Provincial Motor Vehicles Ordinance, 1965.

WHEREAS it is expedient to provide for financial assistance to members of the police force, in order to boost-up them individually as well as collectively and to secure their welfare and welfare of the Shuhada and their families;

AND WHEREAS to achieve the aforesaid objectives, it is desirable to allocate specific share, from the already specified quota of traffic fines as specified in the Provincial Motor Vehicles Ordinance, 1965, to police welfare fund;

It is hereby enacted by the Provincial Assembly of Khyber Pakhtunkhwa as follows:

1. Short title and commencement.---(1) This Act may be called the Provincial Motor Vehicles (Amendment) Act, 2024.

(2) It shall come into force at once.

2. Amendment of section 116-A of the West Pakistan Ordinance No. XIX of 1965.---In the Provincial Motor Vehicles Ordinance, 1965 (West Pakistan Ordinance No. XIX of 1965), in section 116-A, in sub-section (6),-

(a) in clause (b), the word "and", appearing at the end, shall be deleted;

(b) for clause (c), the following shall be substituted, namely:

"(c) 15% shall be allocated for traffic training and education and purchase of machinery and equipment to facilitate traffic; and"; and

(c) after clause (c), as so amended, the following new clause shall be added, namely:

"(d) 10% shall be allocated to police welfare fund, established under the Khyber Pakhtunkhwa Police Welfare Fund Rules, 2014, for the welfare of police force."
