Notices issued under section 10(4) of the Khyber Pakhtunkhwa Provincial Ombudsman Act, 2010 were issued to the Secretary, Agriculture and Fisheries Department Khyber Pakhtunkhwa, Director General, Directorate of Fisheries Department Peshawar and Assistant Director Fisheries Department Swat to meet the allegations contain in the complaint and submit reply including rebuttal if any. In response, the Deputy Director (Admin and Accounts) of the Directorate General of Fisheries stated in their written reply that the employment exchange only provided three names of minority candidates, who were considered and appointed. However, the remaining positions remained vacant. The recruitment process for these vacancies has been initiated and will be completed soon. To facilitate the selection process, the Department Selection Committee has been formed, and they will conduct interviews on 09-01-2023 at 11:00 AM in the office of the Deputy Director of Fisheries in Swat at Matta.

REJOINDER

Reply of the Agency was shared with the complainant for rejoinder/feedback. However, the complainant disagreed with the stance of the Agency.

HEARING

To ascertain the current status of the case, a hearing was scheduled for 08-06-2023 at 11:00 AM. Deputy Director Fisheries Ibrar Alimad represented the Agency while Pardeep Kumar, while Pardeep Kumar complainant attend himself. During the hearing, the Deputy


