CONSTITUTIONAL AND STATUTORY PROVISIONS



CONSTITUTIONAL & STATUTORY PROVISIONS

THE CONSTITUTION OF THE ISLAMIC REPUBLIC OF PAKISTAN

[Art.242]

- 242. Public Service Commission. (1). 1[Majlis-e-Shoora (Parliament)] in relation to the affairs of the Federation, and the Provincial Assembly of a Province in relation to affairs of a province, may, by law, provide for the establishment and constitution of a Public Service Commission.
- 2[(1A) The Chairman of the Public Service Commission constituted in relation to the affairs of the Federation shall be appointed by the President 3[on the advice of the Prime Minister].]
- 4[(1B) The Chairman of the Public Service Commission constituted in relation to affairs of a Province shall be appointed by the Governor on advice of the Chief Minister.]
- (2) A Public Service Commission shall perform such functions as may be prescribed by law.



KHYBER PAKHTUNKHWA PUBLIC SERVICE COMMISSION ORDINANCE 1978

Section 9-Reports of Commission.

- It shall be the duty of the Commission to present to the Governor annually
 a report on the work done by the Commission, and the Governor shall
 cause a copy of the report to be laid before the Provincial Assembly.
- The report referred to in sub-section (1) shall be accompanied by a memorandum setting out so far as is known to the Commission.
 - the case, if any, in which the advice of the Commission was not accepted and the reasons therefore; and
 - (b) the matters, if any, on which the Commission ought to have been consulted but was not consulted and the reasons therefore.

MEMORANDUM

Mr. Governor,

I am having the privilege of presenting the Annual Report of Khyber Pakhtunkhwa Public Service Commission (KPPSC) for the year 2023. As always, the Commission endeavored its utmost to follow strict policy of transparency, fairness, impartiality and merit with aim, on one hand, to establish its credibility and on the other hand, to recommend quality human resource to the government departments. The Commission held five full Commission meetings and took various policy decisions and introduced new initiatives to improve the functioning of the Commission.

- 2. The government of Khyber Pakhtunkhwa revised the zonal allocation formula i.e. six zones instead of five zones, last year and in pursuance, the Commission has notified the zonal rotational cycle on 31st January, 2023. All the administrative departments have been asked to send their requisitions accordingly.
- 3. Before sharing the performance of the Commission, it is submitted for your information that Commission lost one of its good officer Mr. Muhammad Arshad, Director Examination, who was shot dead by the criminals/cheating mafia on his way to office on 24th July, 2023. He was the lynch pin in the Commission's efforts to curb cheating and ensuring secrecy. In order to honour his sacrifice, the Commission dedicated one of its examination halls in his name.
- 4. During the year under report, the Commission processed requisitions of 2060 posts against which total number of applicants were 138757. The Commission interviewed 10697 candidates against 2060 posts and conveyed recommendations of 1876 candidates to respective departments for



appointment. 184 posts remained leftover mainly due to non availability of eligible candidates. (Details are at Appendix-B).

- 5. Similarly, the Commission advertised 569 posts in different pay scales of the Provincial Government departments and Attached departments till end of the year 2023. Out of the total advertised posts, 79 posts were advertised for special quotas i.e., Female Quota: 17, Minority Quota: 51 and Disable Quota: 11. Total candidates who applied against these posts were 58931. (Details are at Appendix-C).
- 6. The Commission conducted 107 Ability Tests for 141473 candidates against 1780 posts. Moreover, one competitive examination for the posts of Tehsildar (BS-16) was also conducted. Details may be perused at **Chapter-V**.
- 7. The Commission remained a party in 492 litigation cases of different nature in various courts. During the period, a total of 93 cases were decided, out of which 81 cases were decided in favor, and 12 cases against KPPSC. In the year under report, 132 new cases were filed against Commission in different courts. On 31st December, 2023, a total of three hundred and ninety three (399) cases were pending as per details given in Chapter-VI.
- 8. Besides, the Commission has taken a few new initiatives. E-Application Form has been revised and updated so as to make it more comprehensive and user friendly. A Computer Lab with 100 Computers has been established and complete IT System has been upgraded. Importantly, computer based solution has been developed for Multiple Choice Questions (MCQs) based ability test, making it difficult for the candidates to indulge in organized cheating through the use of modern technological gadgets. The Commission has also approached Information Technology (IT) Board and National Radio and Telecommunication Corporation (NRTC) in this regard. They proposed a project

of procurement of Mobile detectors and metal detectors approximately costing Rs-75,232 million.

- Having shared the performance of the Commission, I would also like to draw your attention towards certain important outstanding issues.
- 10. Khyber Pakhtunkhwa Public Service had been mentioned in Schedule 1 of the NWFP Govt: Rules of Business (ROB) 1978 as an attached department of Establishment Department but was omitted in the KP Govt: Rules of Business (ROB) 1985. The Commission, being a constitutional institution, may suitably be placed in the Rules of Business (ROB) 1985 as **Special Institution** or an **attached department** of the Establishment Department. The Commission has already referred the case to Establishment Department Khyber Pakhtunkhwa on 12th May, 2022.
- 11. The proposal of Commission regarding holding of screening test for syllabus based competitive examinations on the analogy of Federal Public Service Commission (FPSC), is yet to be processed and approved by the Government of Khyber Pakhtunkhwa. The proposal with full justification was submitted on 27th Oct, 2022.
- 12. Lack of financial autonomy, especially power of re-appropriation, make it difficult for the Commission to smoothly arrange and conduct tests and examinations. A case was forwarded to the Provincial Government on 21st April 2022.
- 13. The low remuneration for services of the paper setters, examiners, advisors and other supervising/invigilating staff of the Khyber Pakhtunkhwa Public Service Commission remains another problem area for the Commission. The remuneration rates were fixed in the year 2017, which have not been revised/enhanced ever since, hence making it difficult for the Commission to

attract quality input. The provincial Finance department has already been requested in this regard on 13th September, 2022.

- All employees of the KPPSC, except Chairman and Members are getting Public Service Commission Allowance @ 20% of mean of Basic Pay Scale 2016 since 01.07.2016. The national pay scale have been revised w.e.f 01.07.2017 and again on 01.07.2022 but the KPPSC allowance, being fixed on mean of the time scale of 2016, did not enhanced. The Commission requests that the KPPSC Allowance of the KPPSC employees may be enhanced from 20% of the mean of 2016 pay scales to 50% of the mean of 2022 pay scales. The cases have been submitted to the government on 01/08/2023.
- 15. The Commission and its employees may be given right to the Provincial Government Residential Accommodations on the analogy of the employees of all attached departments, Provincial Assembly, Peshawar High Court and MTI Hospitals.
- 16. Khyber Pakhtunkhwa Public Service Commission sincerely extends its gratitude to your goodself and the Provincial Government for support and sponsorship. At the same time the Commission lauds the untiring efforts of advisors, subject specialists, departmental representatives and paper setters, who provide valuable services to the Commission in finding right person for the right position. The Commission looks forward to their suggestions and opinions for bringing improvement in its system.

COMPOSITION

In the light of Sub section (i) of Section 4 of the Khyber Pakhtunkhwa Public Service Commission Ordinance, 1978 the Chairman and Members of the Commission are appointed by the Governor for a term of three years or till the member attains the age of 65 years (whichever is earlier) with effect from the date of entering upon office. The Commission consists of a Chairman and 11 Members including representation of a Member each from Engineering, Health Sector and female.

THE COMMISSION

2. The Chairman, Capt. Sikander Qayyum (Retd) and seven Members i.e., Mr. Shad Muhammad, Mr. Sadiq Kamal Khan, Mr. Laiq Zaman, Mr. Masud ur Rahman, Syed Kamran Shah, Mr. Farmanullah Anjum and Dr. Tahir Nadeem Khan joined the Commission in the year 2022 while Prof. Dr. Razia Sultana was appointed in the year 2023 for period of three years or till 65 years whichever is earlier. The Commission held five (05) meetings during the year under report. The composition of the Commission by the end of the year was as under: -



4. The appointment, promotion and transfer of the officers and staff of the Commission are regulated under the Khyber Pakhtunkhwa Public Service Commission Officers and Servants (Terms and Conditions of Service) Regulations, 1985 framed under Section 3(2) (b) of the Khyber Pakhtunkhwa Public Service Commission Ordinance, 1978. Total sanctioned strength of employees of the Commission is 305 whereas the existing strength during the year under report is 280 while 25 posts

remained vacant for various reasons. Recruitment process for filling of the vacant posts has been initiated and the vacant posts will be filled soon. Details of the posts are available at Appendix A.

FUNCTIONS OF THE COMMISSION

- 5. As per Section 7 of the Khyber Pakhtunkhwa Public Service Commission Ordinance, 1978 as amended from time to time read with Rule 3 of the Khyber Pakhtunkhwa Public Service Commission (Functions) Rules, 1983 the Commission shall perform the following functions:-
 - Conduct tests and examinations for recruitment of persons to:-
 - the civil services of the Province and civil posts in connection with the affairs of the Province in basic pay scales 16 and above or equivalent; and
 - ii) posts in basic pay scale 14 and 15 or equivalent in all Administrative Departments and Attached Departments of the Government except the District cadre posts and posts of Computer Operator, Assistant, Junior Scale Stenographer.
 - To advise the Governor: -
 - on matters relating to qualifications for, and method of recruitment to, services and posts referred to in clause (a)
 - ii) on the principles to be followed in making;
 - initial appointments to the services and posts referred to in clause (a);
 - appointment by promotion to posts in BPS-17 and above; and
 - transfer from one service to another; and
 - iii). any other matter which the Governor may refer to the Commission.

COMMISSION'S ROLE IN PUBLIC SECTOR UNIVERSITIES

As provided for in the University Model Act, 2015 of the Public Sector Universities, the Chairman or his nominee has to perform as Member of the Selection Boards of the Universities for appointment of officers and teachers of the University in BPS-17 and above. During the period under report, the following Members represented the Chairman of the Commission on the Selection Boards of various universities of Khyber Pakhtunkhwa as on 31.12.2023:-

FUNCTIONING OF THE COMMISSION

- 7. For the smooth conduct of business, the Commission holds its meetings regularly where regulations are approved and decision are taken on important issues. The Commission provides equal chance to all candidates, to prove themselves fit for the job applied. Selection is made of only those who prove their mettle. They are expected to emerge from all tests/ interview with the insignia of skills thus making themselves eligible for the post. Thus everyone is provided an opportunity to demonstrate their ability in a transparent manner. The aim is to select the best. The Commission always prefers selection of candidate on the basis of his/her ability and intelligence rather than any position or privilege. Thus the career is open to talent wherever it is born. The Commission by adhering to the above is always cognizant to the perception of public toward the credibility and integrity of the Institution. The legitimacy of the Institution is always based on public trust. It will keep up to the expectation of a public as well as government and will not allow anyone trying to erode the trust reposed in the institution.
- 8. Candidates after qualifying Written Exam or Ability Test are to go through the deciding phase i.e. Oral examination/ interview. The Commission

normally conducts 5 parallel interview panels daily, each comprises of Honorable Members assisted by a Subject Specialist from a university and departmental representative from the department concerned. The purpose of interview is to interact face to face with the candidates to test orally candidate's knowledge, with their suitability for the post. The interview panel expects the needed subject knowledge and gauges critical thinking capacity of the candidate The basic aim is to discourage the method of rote learning prevailing in education system. Another basic feature which is required to be checked in oral exam is that of capability of independent thinking supported by cogent arguments. All these qualities enable them to shift from status quo and adopt modern techniques of good governance and service delivery. The government in its endeavor earnestly requires not only educated youth, but also motivated and hard working staff to run the different organ of the state. Besides these recruitment/ selection of candidates, the Members of the Commission play important role in selection process of the public sector universities. Being external member of Selection Board of the concerned universities, the Commission also ensures merit and fair play in selection processes of the public sector universities. At the same time, the office of the Hon'able Chancellor/ Governor is kept informed.





CHAPTER - III

ADMINISTRATIVE ACTIONS

For smooth conduct of business, the Commission periodically holds its meetings to discuss various issues faced by the organization and seek out durable solution for it. In the year under report, five (05) meetings of the Commission were held and various issues were discussed and highlighted.

DISCIPLINARY ACTION

2. The commission took various disciplinary actions against officers/ officials and candidates who were found involved in UFM cases. in the year under report, total thirty (30) candidates were disqualified / debarred / banned from all types of examination and interviews, on account of using unfair means in tests/ examinations by using mobile phones and electronic devices. Keeping in view the nature of UFM, various penalties were imposed upon them ranging from 1 year to 3 years disqualification. Furthermore, the Commission also conducted five inquiries against officers/ officials of the Commission wherein 3 officials were issued censure and two were exonerated.

COMPLAINTS RECEIVED AND PROCESSED UNDER PRIMEMINISTER PERFORMANCE DELIVERY UNIT (PMDU)

3. The Govt. of Pakistan has established Prime Minister Performance Delivery Unit in 2013 for resolving complaints and grievances of citizens against government departments. During the year 2023, KP PSC received total 1794 complaints lodged by the candidates in online portal of PMDU. All the complaints/ grievances were addressed one by one and not a single complaint was left pending against KP PSC.



COMPLAINTS RECEIVED AND PROCESSED UNDER RIGHT TO INFORMATION (RTI)

4. Similarly, Right to Information (RTI) is a provincially established organization under an act of Provincial Assembly in 2013 which ensures the right of citizens to access relevant information of the government departments related to their grievances and its solution. During the year under report, total 55 applications/ complaints were lodged by the candidates against KP PSC using the forum of RTI. All the complaints were resolved amicably and nothing remained pending on the part of KP PSC.

CHAPTER - IV

OUTSTANDING ISSUES

Status of KPPSC is yet to be determined. For this to take effect there is a need to amend/update the Rules of Business (ROB) of KP Government. The Commission has referred the case to Establishment Department on 12th, May 2022.

- With the mushroom growth of Public and Private Sector Universities the number of candidate are increasing manifold. Hence there is a need to reintroduced screening test for syllabus based competitive examination on the analogy of the Federal Public Service Commission. Case with full justification has been forwarded to provincial government on 27.10.2022.
- Lack of financial autonomy especially powers of re-appropriation, make it difficult for the Commission to smoothly arrange and conduct tests and examination.
 Case with full justification has been forwarded to provincial government on 21.04.2022.
- 4. The KP PSC is going through the hectic schedule of exams, tests and interview throughout the year. The low remuneration for the services of paper setter, examiner, advisor and other external and internal supervisory/ invigilating staff remains another soaring point for the Commission. The remuneration rate were fixed in the year of 2017 and since then not revised/ enhanced, hence making it very difficult to attract quality input. The advisors, examiners and supervisory/ invigilating staff constantly complain for the low rate of remuneration. They give the reference of FPSC, other commission and BISEs for high rate of remuneration being paid to the supervisory/invigilating staff. The Finance Department has already been requested in this regard on 13.09.2022. The existing rate of remuneration in the KP PSC is at Appendix-D
- Employees of the Commission KP PSC have neither its own colony nor they have rights in the Provincial Government Residential Accommodations. The Commission and its employees may be given right in the Provincial Government



Residential Accommodations on the analogy of employees of all the Provincial Government departments, Attached Department, Provincial Assembly, Peshawar High Court and MTI Hospitals by making necessary amendments in the relevant law/rules of the Allotments of Provincial Government Residential Accommodations.

- 6. All permanent employees of Public Service Commission are getting Public Service Commission Allowance @ 20% of the mean of Basic Pay Scale 2016 since 01.07.2016. With the revision of national pay scale in 2017 and in 2022, all other similar allowances both at federal and provincial level have been enhanced. Take for instance, the allowance for the Secretariate employees has been increased from 50% to 100% but PSC allowance remains the same. The KP PSC has already requested the Finance Department through Administration Department for enhancement of the PSC Allowance from the existing 20% on mean of Basic Pay Scales of 2016 to 50% on mean of 2022 pay scales. In view of the above, special directives may be issued to the Finance Department for enhancement of PSC Allowance from existing 20% on mean of Basic Pay scale of 2016 to 50% on of Basic Pay as a special incentive for Commission employees, keeping in view high inflation rate, price hike, devaluation of rupee and increasing of rental of private accommodation in the open market.
- 7. The KP PSC is facing the acute shortage of funds which is adversely affecting the recruitment process and routine business of the office. The withheld budget as well as additional grant amounting to total Rs. 52,184,715/- may please be provided so that the recruitment process continues smoothly and to clear the outstanding liability without further financial stress.
- 8. During the last few years, the Commission has observed that the candidates appearing in the exams/ tests adopt unfair means by using cheating devices and various types of electronic gadgets including mobile phones, smart watches, master card and bluetooth ear bugs etc. The Commission is trying its best to curb the increasing trend of cheating and adopt every possible measure in this regard. The Commission approached IT Board and National Radio & Telecommunication Corporation (NRTC) to share possible solution to curb the increasing trend of using electronic gadgets for cheating purposes. They proposed a project of procurement of mobile detector and metal detectors which cost about Rs. 75.232 Million.

INITIAL RECRUITMENT

The Commission makes two types of recruitments i.e., syllabus based and non-syllabus based or general recruitment. In case of syllabus based recruitment, the candidates are first put through the written examination prescribed in the syllabus by the department concerned. After qualifying the written examination with the required standard of proficiency, the candidates are called for interview and subsequently recommended for appointment, based on their competitive merit and zonal allocation. In case of non-syllabus based recruitment, no standard is prescribed by the department in the Service Rules. If the number of applicants is disproportionate to the number of vacancies then screening/ ability test is conducted for short listing the candidates. Subsequently interviews are conducted and their merit is determined on the basis prescribed weightage of their academic record, screening test marks and marks obtained in the interview. If the number of candidates is limited as compared to number of posts then interviews are arranged without going through the process of screening test. The qualified candidates for such posts are recommended in accordance with their merit order and zonal allocation.

2. During the year under report, the Commission processed 191 requisitions for 2060 posts against which total number of applicants were 138757. The Commission interviewed 10697 candidates against 2060 posts and conveyed recommendations of 1876 candidates to respective departments for appointment. 184 posts remained leftover mainly due to non availability of eligible candidates. Details are at Appendix-B.



SCREENING/ ABILITY TESTS

The Commission conducted 107 Ability Tests against 1780 posts for

COMPETITIVE EXAMINATIONS

COMPETITIVE EXAMINATION FOR THE POST OF TEHSILDAR

5. The Commission conducted a competitive exam for the post of Tehsildar in Revenue and Estate Department Adv. No. 02/2023 w.e.f.27th December, 2023 to 1st January, 2024. Total applicants were 1909 where after scrutiny of documents, only 1022 candidates were found eligible. However, only 368 candidates appeared making 36 percent attendance with respect of eligible candidates.

RECOMMENDATION OF INSPECTOR IN POLICE DEPARTMENT

6. The Commission conducted interview for the post of Fast Track Promotion to rank of Inspector. Total **379** candidates applied whereas **339** candidates were declared ineligible; **325** didn't possess the required length of experience and **14** were not confirmed in the rank as per service rules of the Police Department. Only **35** out of **36** eligible candidates appeared in the written examination. Subsequently, result was announced on 17th November, 2022 where **15** candidates qualified for interview conducted on 1st and 2nd February, 2023. Fourteen candidates were recommended as Inspector (BPS-16) while one post kept pending due to court case and the remaining **35** post remained unfilled which will be re-advertised in due course of time.

RECOMMENDATIONS OF ASSISTANT SUB-INSPECTOR UNDER FAST TRACK PROMOTION

The Commission recommended 74 Assistant Sub-Inspector (BPS-11) under Fast Track Promotion Quota to the Provincial Government in the year 2023. Result of the written examination was announced on 23.05.2023 wherein 274 or 27% candidates qualified for interview. Accordingly, interview was arranged from 15.08.2023 to 15.09.2023 for 267 candidates while candidature of 7 candidates was rejected due to various reasons. Furthermore, 225 candidates qualified the interview, 39 failed while 3 candidates remained absent from the interview. Subsequently, 74 candidates were allocated and their recommendations were sent to the Government for appointment while one post kept pending due to court case.

RECOMMENDATION OF ASSISTANT SUB INSEPCTOR TRAFFIC WARDEN IN SERVICE

- 8. The Commission recommended 33 Assistant Sub-Inspector Traffic Warden in Service (BPS-11) in Police Department in the year 2023. The written exam was conducted from 15th to 22nd November, 2022. Total candidates were 175 however, 93 candidates were rejected as they did not fulfill the given criterion. Total 66 candidates appeared in the Written exam where 34 or 52% candidates in respect of appeared have qualified for the interview. After conclusion of interview from15th August, 2023 to 21st September, 2023, 33 candidates were recommended while 44 posts remained unfilled due to non availability of eligible candidates.
- 9. It is pertinent to mention here that 11 posts of Female Quota and 3 Posts of Minority Quota also remained unfilled as there were no eligible candidates to appear in the written exam. As a result, the unfilled posts will be re-advertised in due course of time.



RESULT OF WRITTEN EXAMINATION FOR PROVINCIAL MANAGEMENT SERVICE (PMS) 2022

- 10. The Khyber Pakhtunkhwa Public Service Commission conducted written examination for the posts of Provincial Management Service Officers (BPS-17) for 33457 candidates previously carried from 4th October 2022 to 22nd October, 2022 at all divisional headquarters of the Province.
- 11. The result of the written competitive examination PMS for 95 posts was announced on 26th October, 2023 wherein total 226 candidates with 3.4 % passing ratio qualified the written exam. In the competition total 6585 candidates appeared: out of 5217 male candidates, 171 with passing ratio 3.2 % while 1368 female candidates, 55 candidates with 4% passing ratio qualified for next phase. In term of special quota, 55 and 91 candidates against Minority and Disable Quota respectively appeared in the written exam wherein 3 candidates from disable quota qualified while no one qualified from Minority Quota. Among the pass candidates, 164 are fresh and 62 are in-service candidates. While discipline-wise, 67 candidates from engineering and 7 from medical profession.

PSYCHOLOGICAL TESTS/ ASSESSMENT

The Psychology Wing carries the responsibility to check the suitability of candidates for the respective post and to assess whether the candidates are mentally healthy to carry out the assigned responsibilities. It weighs the candidates in the areas of intellectual level, emotional stability, competency, strong will power and leadership quality during Psychological analysis. It adopts various techniques and tools i.e. Psychological Aptitude Test, Group Discussion and individual Interview and prepares personality assessment report of each individual.



- 13. For the said purpose, the Psychology Wing assessed 226 candidates qualified the PMS written examination. The Wing also arranged the Psychological Aptitude Test from 28.11.2023 to 29.11.2023 in morning and in evening session. Group discussion and Psychological Individual Interview arranged from 11th December, 2023 to 17th January, 2024. Personality assessment report of each individual is considered during final interview.
- Interview for qualified candidates in the written exam of PMS is scheduled from 01.01.2024 to 20.02.2024.

The Commission has a Separate Litigation Wing comprising a Senior Law Officer BPS-18, two Law Officers BPS-17 and staff headed by a Member of the Commission. The Litigation Wing pursues all legal and litigation cases of the Commission. During the year under report, the Commission was a party in total 492 litigation cases out of which 93 were decided by the honorable courts while 399 cases still remain pending before various courts (Appendix-E). 


FIGURE: 1 Nature of Litigation Cases Related to KPPSC

FIGURE: 3 GRAPHICAL COMPARISON OF NEW CASES INSTITUTED IN YEAR 2021, 2022 & 2023





FIGURE: 4 GRAPHICAL COMPARISON OF PENDING CASES IN YEAR 2021, 2022 & 2023

FIGURE: 1 GRAPHICAL DISPLAY OF DEPARTMENT WISE APPLY FOR VARIOUS POSTS IN 2023




FIGURE: 2 GRAPHICAL DISPLAY OF DEPARTMENT -WISE RECOMMENDATION IN 2023




FIGURE: 3 GRAPHICAL DISPLAY OF DEPARTMENT WISE UN-FILLED POSTS IN 2023





FIGURE: 4 GRAPHICAL DISPLAY OF DEPARTMENT WISE TOTAL AND FILLED POSTS IN 2023



FIGURE: 5 GRAPHICAL DISPLAY OF SCALE-WISE RECOMMENDATION IN 2023




ZONE-WISE RECOMMENDATIONS

3. The Commission recommended 1876 candidates to the Government for appointment from five zones of the province. The Provincial Government notified on 22 December, 2022, a new zone .i.e (Zone-VI) which included districts of Battagram, Kohistan Lower, Kohistan upper, Kolai Palas Kohistan, Torghar, Shangla, Buner, Tank, Backward Area of District Swabi (Gadoon Tehsil), Haripur and Mansehra. However, no recommendations were made from Zone-VI during the year under report. Zone-wise details of recommendations are as under: -

FIGURE: 6 GRAPHICAL DISPLAY OF ZONE-WISE RECOMMENDATIONS IN 2023




RECOMMENDATIONS AGAINST SPECIAL QUOTA IN 2023

4. As Per the policy of Provincial Government of Khyber Pakhtunkhwa, special quotas of 10 %, 5 % and 2 % were reserved for Female, Minorities and Disable candidates respectively. KP PSC advertises posts falling to the share of zones and quotas (Female, Minority and Disable) jointly. A combined merit list is prepared where from the general posts falling to the share of zones are filled. Candidates who do not come in the orbit of selection under zonal posts are then considered in quotas and thus all the posts are filled from a common merit list. The Commission considers the recruitment of Minority Quota as top priority after the august Supreme Court order for early finalization of the same cases. All special quota posts that remain unfilled are advertised later on and are processed on priority basis. Details of recommendations under special quota are as follows: -




FIGURE: 1 GRAPHICAL COMPARISON OF POSTS ADVERTISED IN THE YEAR 2021, 2022 AND 2023





CHAPTER - IX

SUGGESTIONS OF THE COMMISSION FOR IMPROVEMENT IN EDUCATIONAL STANDARD AND SERVICE EFFICIENCY

The Commission, mandated to make selections for various categories of positions under the Government, is always in a better position to have a firsthand knowledge of the standard of education by means of interviewing young graduate candidates seeking government jobs. Qualifying written test bring the candidate to the table of interview. The interview provides opportunity to the panel members to look into various personality traits of the candidates particularly their confidence, conviction, composure, mannerism etc. The foremost test is to check his familiarity with the subject and comprehension of issues. The next stage is their analytical skills which are needed for building logical arguments. Besides above, the presentation skills of the candidate are also assessed. Based on these interactions with candidates, the Commission identifies and highlights the weaknesses of the system which can be properly addressed by policy makers by reforming the educational system.

- 2. Not much change has been observed this year, compared to previous year, in the performance and behavior of the aspiring candidates for various posts advertised by the Commission. With the exception, of an infinite small segment of genuinely talented individuals, most of the candidates, cannot suitably communicate what they have been imparted in educational institutions. They cannot simply and confidently express their ideas when facing the interview panel.
- 3. Apart from communication issues, the comprehension base of majority candidates is also noticed to be weak. Analytical answers are rarely heard from the majority. The "Note-Culture" developed at College and University level dissuades the students from in-depth study of the subject. Student interaction with teachers and attending library for reading are on decline. Candidates rely on substandard texts and guidebooks rather than original materials. The problem of limited knowledge hampers the candidate's actual potential. Passing percentage in the recent PMS Examination wherein only 226 candidates could qualify the written exam, out of 6585 candidates who appeared, is a grim reminder of the falling standard of education.




- Lack of interest in book reading and newspapers has handicapped the students to get-in depth and diverse knowledge. Every candidate is expected to always have sufficient quantum of basic knowledge of own religion, culture, country and the major happenings in the surroundings in addition to that of his/ her subject or specialty. Versatile knowledge is lacking in candidates. Most of candidates were found unaware of the major happenings at regional and international levels.
- 5. Senior graduate candidates do not bother to update themselves with the changes in curriculum of the degrees they have acquired long ago. Even they do not study the course they studied while students. While in service, they not only forget the course studies but also do not acquaint themselves with the rules and regulations of the institution they serve in. Exceptions are always there but those are small in ratio.
- 6. Just like previous years, misuse of Disability Quota on the part of certain unconscientious candidates has again been observed. Incomprehensive definition of "disability", absence of well defined criteria and in-elaborate remarks/recommendations of the certifying authority/medical board seemingly facilitate undue claim for the disability quota. On the basis of insignificant, flimsy or minor nature of impairments, neither even palpable nor hampering activities or movements of claimants, disability certificates are manipulatively managed/arranged. Thus genuinely deserving candidates with major or serious physical disability get deprived of the benefit of this special concession. The policy needs to be meaningfully reviewed for loopholes to be plugged, relevant criteria/mechanism to be well defined and necessary safeguards to be provided against misuse or abuse of the Disability Quota in the interest of genuinely deserving candidates.

<u>SUGGESTIONS</u>

- The educational institutions are required to work on improving students' communication skill. The students, within the institution, should be groomed to practice how to communicate what they have been imparted and express their ideas and future plans in comprehensible way.
- ii) The note and guide culture must be discouraged at all levels. Analytical method should be made the way of study in educational institutions.



- There is a dire need for education reformation in line with modern day trends and standards. It will set the pattern to achieve the goal of high standard of education.
- There is no system of teacher evaluation. Now it is time for the higher education institutions to seriously focus on quality teaching and effective learning to produce knowledgeable students.
- v) Fields need to be identified and set by the state for the state progress. Interest and aptitudes of the students should be identified by the teachers at institutional level.
- vi) Modern methods of examination and assessment ought to be acquired not only for the education institutions but also for the institutions like Public Service Commissions.
- vii) Interest, aptitude and capacity do matter while getting or imparting education to students. Highly talented students haring capacity and aptitude to get higher and specialized education should be provided the opportunity by the state, while vocational, technical and skill development trainings should be imparted to mediocre students keeping in view market requirements. Technical and vocational training programs should be revisited and be designed according to market needs with emphasis on research and technical expertise instead of theoretical knowledge.
- viii) The Disability Quota policy may be reviewed to be meaningfully improved and fortified. The definition of disability should be made unambiguously clear and elaborate. Formats of the Disability Certificate and Proforma for Medical Board's recommendations be made more elaborate and informative respecting the nature and details of disability, also specifying whether the disability is permanent or temporary and highlighting suitable fields/professions for such disable individuals/candidates. Detailed guidelines/instructions need to be issued for the facility and guidance of the certifying authority/medical board.
- Moreover, necessary instructions may be issued to all the administrative departments to work out disabilities which are allowed for specific post(s) and such disabilities may be catered to in the service rules of the relevant posts.




