1. The Director General Sports and Youth Affairs Khyber Pakhtunkhwa Peshawar (Acquiring Department) vide his office letter No.26/prov of sports facilities at Tehsil HQtrs/ADP/U/2013 dated 07-08-2013 requested for the acquisition of land situated in Moza Maidan Tehsil & District Battagram for the Construction of Playground Tehsil & District Battagram.

NOTIFICATION UNDER SECTION-4 OF LAND ACQUISITION ACT-1894

2. The Deputy Commissioner/District Collector, Battagram issued Notification under section -04 of the land Acquisition Act (LAA)-1894 vide No 217-220/DC/LA dated 16-01-2014 for the land measuring 36 Kanals 19 Marlas, which was published in official Gazette on 29-08-2014. - 10. The affected land owners in their views, that the average Yaksala rates of the said Moza are very low, therefore they insisted for alternate site and previous acquired land may be de-notified. The Deputy Commissioner/ District Collector Battagram rejected their views, which could not be entertained as required under relevant rule.

DE-NOTIFICATION OF SECTION-4 IMPOSED FOR "CONSTRUCTION OF PLAY GROUND AT MOZA MAIDAN TEHSIL & DISTRICT BATTAGRAM".

Sir,

I am directed to refer to the subject noted above and to state that the Project "Establishment of Play Ground in Khyber Pakhtunkhwa on need basis" was approved by PDWP on 09-10-2013 at a cost of Rs. 2268.00 Million. The scheme was revised at a cost of Rs. 4725.00 Million by PDWP on 19-11-2014 for inclusion of more 39 No's of Tehsils. The project was again revised and 2nd approval was accorded on 25-08-2022 at a cost of Rs. 4725.00 Million, wherein and the cost of each facility has been increased from Rs. 63.00 Million to Rs. 200.00 Million.

The site for the subject playground was selected (private land) and Section-4 was issued on 36 Kanal 19 Marla on 16-01-2014 and payment made on 09-05-2016, accordingly. Later on, the land has been increased from 36 Kanal 19 Marla to 68 Kanal 16 Marla and the 1st corrigendum of Section-4 was issued on 02-06-2014. Due to enhancement in cost from approved limit, the Director General Sports requested to decrease the land to 36 Kanal & 19 Marla on 17-06-2016. A 2nd corrigendum was issued on 26-09-2016.

Subsequent to the foregoing, the then MPA-PK-59 requested for change of site and identification of new feasible site on 25-08-2016 through letter received from District Sports Officer Battagram. The Hon'ble Commissioner Hazara had also issued Notification under 6 & 17 on 12-09-2017. In the meanwhile the land owners filed a writ petition title Muhammad Hazara Shah, Syed Ali Shah & others VS Govt of Khyber Pakhtunkhwa was filed at High Court in Abbottabad. The Hon'ble High Court Abbottabad had decided the case on 26-09-2020 by referring the case to Commissioner Hazara. The Commissioner Hazara Division had decided the case on 04-02-2021 and 3rd Corrigendum Notification was issued of 29 kanal & 19 marla on 10-02-2021 accordingly. Award of land has already been done on 26-03-2021.

The land owners filed a second writ petition in Peshawar High Court, Abbottabad Bench. The case was again disposed and the court directed Commissioner Hazara to listen objections of land owners and resolve thematter. A meeting was held on 01-02-2023 under the chairmanship of Commissioner Hazara to listen both the parties and constitute a committee to visit the site and submit a report within one week 7 days. Assistant Commissioner Battagram submitted a report to Deputy Commissioner Battagram wherein the following three sites were selected for construction of Play Ground, 1. Maira Khubanda 2. Banian 3. Romai (Tamai). The acquisition cost of these sites are very absorbent and beyond the approved limit of the approved PC-1.

Furthermore, it is stated that the said site is disputed since 2014 and due to financial constraint, no funds has been released during the last financial year to the said scheme. The Provincial Government is not in position to purchase any alternate site which is on very high side. The DCE's of the scheme was also prepared on CSR 2013, therefore physical execution is not possible and would require revision at an enhanced cost.

In light of the above, it is therefore requested that the Section-IV on the above mentioned site may kindly be De-notified under section-48 of Land Revenue Act 1894, in the best public interest, please.
