No.PA/Khyber Pakhtunkhwa/Bills-38/2025/1398.— The Bank of Khyber (Amendment) Bill, 2025 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 6th January, 2025 and assented to by the Governor of the Khyber Pakhtunkhwa on 16th January, 2025 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

ACT

further to amend the Bank of Khyber Act, 1991.

WHEREAS it is expedient further to amend the Bank of Khyber Act, 1991 (Khyber Pakhtunkhwa Act No. XIV of 1991). for the purposes hereinafter appearing:

It is hereby enacted by the Provincial Assembly of Khyber Pakhtunkhwa as follows:

1. Short title and commencement.---(1) This Act may be called the Bank of Khyber (Amendment) Act, 2025.

(2) It shall come into force at once.

2. **Amendment of section 11 of the Khyber Pakhtunkhwa Act No. XIV of 1991.**---In the Bank of Khyber Act, 1991 (Khyber Pakhtunkhwa Act No. XIV of 1991). in section 11, in sub-section (1),-

(a) in clause (a), for the word "three", the word "two" shall be substituted; and

(b) in clause (b),-

(i) for the word "four", the word "five" shall be substituted; and

(ii) in sub-clause (ii), for the word "two", the word "three" shall be substituted.
