further to amend the Institute of Management Sciences Ordinance 2002.

WHEREAS it is expedient further to amend the Institute of Management Sciences Ordinance, 2002 (N.W.F.P Ordinance No. XXXVII of 2002), for the purposes hereinafter appearing;

It is hereby enacted by the Provincial assembly of Khyber Pakhtunkhwa as follows:

- 1. Short title and commencement.---(1) This Act may be called the Institute of Management Sciences (Amendment) Act, 2025.
- (2) It shall come into force at once.
- 2. Amendment of section 10 of the Khyber Pakhtunkhwa Ordinance No. XXXVII of 2002.— In the Institute of Management Sciences Ordinance, 2002 NWFP Ordinance No. XXXVII of 2002), in section 10, sub Section (1), in clause (i),

for the words "Governor of the North - West Frontier Province", words "Chief Minister, Khyber Pakhtunkhwa", shall be substituted.
