The locals of the area staged protest in front of Jani Khel Fort. After negotiation with local elders by District Administration and LEAs, it was agreed that a case of special compensation package of Rs. 2.5 million will be forwarded to PDMA /Provincial Government for provision /approval.

It is therefore, requested to accord approval /sanction for grant of special compensation package to legal heirs of the above mentioned victim, @ Rs. 2.5 million, per head in the light of Rule 4 (2) of Government of Khyber Pakhtunkhwa, Provincial Disaster Management Authority, Civil Victims Compensation Regulations 2019.

Also, kindly release an amount of Rs. 2.5 millions under head CVSF on urgent basis for further and timely payment to the legal heirs of the victims.


It is therefore, requested that the complete case alongwith required documents may be forwarded to this office for further processing of the subject case.
