# PROPOSED AMENDMENTS IN THE KHYBER PAKHTUNKHWA FINANCE BILL, 2025

### CLAUSE 2

**Mr. Ahmad Kundi, MPA** to move that in clause 2, in the Schedule-1, in the proposed Article No. 6(A), in third column of the Table, the words "or Deputy Commissioner, as the case may be, whichever is higher" may be deleted.

## CLAUSE 5

- **1. Mr. Ahmad Kundi, MPA** to move that in clause 5, in sub-clause (a), in the proposed proviso, the figure "51" may be deleted and thereafter, after the words, brackets, roman figures and figures "Khyber Pakhtunkhwa Revenue Authority Act, 2022(Khyber Pakhtunkhwa Act No. XVIII of 2022)", the words "and Federal Board of Revenue" may be added.
- **2. Mr. Ahmad Kundi, MPA** to move that in clause 5,in sub-clause (b), in the proposed proviso, the words and comma "contract carriage permit," may be deleted, and thereafter, after the words, brackets, roman figures and figures "Khyber Pakhtunkhwa Revenue Authority Act, 2022 (Khyber Pakhtunkhwa Act No. XVIII of 2022)", the words "and Federal Board of Revenue" may be added.
- **3. Mr. Ahmad Kundi, MPA** to move that in clause 5,in sub clause (c),in the proposed section 97-A, for the words "two months", "one lac" and "fifty thousand", the words "one year", "five lacs" and "two lacs" may be substituted, respectively.
- **4. Ms. Sobia Shahid, MPA** to move that in clause 5, the sub-clauses (a) and (b) may be deleted and the remaining sub-clauses may be renumbered accordingly.

### CLAUSE 7

**Mr. Ahmad Kundi, MPA** to move that clause 7may be deleted.

### **CLAUSE 8**

- **1.Mr. Aftab Alam Afridi MPA**, to move that after clause 8, the following new clauses shall be inserted, namely,-
- (a) "8A. Insertion of new section 17A to Act No. XXII of 2013.--- In the Khyber Pakhtunkhwa Arms Act, 2013 (Khyber Pakhtunkhwa Act No. XXII of 2013). after section 17, the following new section shall be inserted, namely:
  - "17A. Penalty for manufacturing or fabricating fake arm licenses.---(1) Whoever, falsely makes, prints or fabricates any arm license or is involved in the making, printing or fabricating of arms licenses to support any claim or title shall be punished with imprisonment for a term which may extend to three years and a fine which may extend to one lac but shall not be less than rupees fifty thousand.

- (2) Whoever, fraudulently or dishonestly uses as genuine any arm license, which he knows or has reason to believe to be a forged arm license, shall be punished in the same manner as provided in sub-section (1).";
- **2.Mr. Ahmad Kundi, MPA** to move that in clause 8, in sub-clause (b), in the proposed proviso, in the third column of the Table, for the figures "15" and "25", the figures "20" and "30", may be substituted, respectively.

### CLAUSE 9

- **1.Mr. Ahmad Kundi, MPA** to move that in clause 9,in sub-clause (a), in the proposed Serial No. 16A,in the third column of the Table, for the figure "350", the figure "300" may be substituted.
- **2.Mr. Ahmad Kundi, MPA** to move that in clause 9, in sub-clause (b), the Serial No. "45" and third entry under Royalty Rates may be deleted and thereafter in the rest of entriesfor the figures "350" under Royalty Rates, the figures "300" may be substituted, respectively.
- **3.Mr. Ahmad Kundi, MPA** to move that in clause 9, in sub-clause (d), in the third column of the Table, for the figure "350", the figure "300" may be substituted.
- **4.Mr. Ahmad Kundi, MPA** to move that in clause 9, in sub-clause (f), in the third column of the Table, for the figure "350", the figure "300", may be substituted.

#### CLAUSE 10

- **1.Mr. Ahmad Kundi, MPA** to move that in clause 10, in sub-clause (a), in clause (iv), in the proposed clause (aaa), comma and the words ", including but not limited to digital, electronic or online platforms and" may be deleted.
- **2.Mr. Ahmad Kundi, MPA** to move that in clause 10, in sub-clause (c), in the proposed clause (a), for colon, the full stop may be substituted and thereafter the first and second provisos may be deleted.
- **3.Mr. Ahmad Kundi, MPA** to move that in clause 10, in sub-clause (j), clause (ii) may be deleted.
- **4.Mr. Ahmad Kundi, MPA** to move that in clause 10, in sub-clause (m), in clause (i), in the proposed Serial 4B, in the third column of the Table, the words, brackets, figures and coma "rupees two hundred thousand (200,000) or" and the words and comma "whichever is higher," may be deleted and thereafter, in the fourth column after the word "Officer", the words and figure "not below grade 17" may be inserted.
- **5.Mr. Ahmad Kundi, MPA** to move that in clause 10, in sub-clause (o), in the proposed section 70A, in sub-section (1), in paragraphs (a) and (b), for the word "five", the word "three", may be substituted, respectively.
- **6.Mr. Ahmad Kundi, MPA** to move that in clause 10, in sub-clause (o), in the proposed section 70A, in sub-section (3), for the word "six", the word "three", may be substituted.

- **7.Mr. Ahmad Kundi, MPA** to move that in clause 10, in sub-clause (r), in the proposed First Schedule, at serial No.1, in the third column, after the word "Hostels", the words "either houses converted to hostels or proper hostels" may be inserted.
- **8.Mr. Ahmad Kundi, MPA** to move that in clause 10, in sub-clause (r), in the proposed First Schedule, at serial No.5, in the third column, after the word "Hajj", the words "and Umrah" may be added.
- **9.Mr. Ahmad Kundi, MPA** to move that in clause 10, in sub-clause (r), in the proposed First Schedule, at serial No.16, in the third column, the words "Privately owned library or a Public library" may be inserted.
- **10.Mr. Ahmad Kundi, MPA** to move that in clause 10, in sub-clause (r), in the proposed First Schedule, at serial No.17, in the third column, for the words "or local governments in the public interest", comma and the words ", local governments or non-government organizations in the public interest" may be substituted.
- 11.Mr. Ahmad Kundi, MPA to move that in clause 10, in sub-clause (r), in the proposed First Schedule, at serial No.22, in the third column, the words, "Such services as provided by the Provincial Government, local government, community, any housing society, non-government non-profit organizations or individuals" may be inserted.
- **12.Mr. Ahmad Kundi, MPA** to move that in clause 10, in sub-clause (r), in the proposed First Schedule, in the Note, after the existing full stop, the words "The Government will notify all the above mentioned exemptions for general public information in three widely circulated newspapers within three months from the commencement of this Act.", may be added.
- **13.Mr. Ahmad Kundi, MPA** to move that in clause 10, in sub-clause (s), in the proposed Second Schedule, in Part-I, at serial No.1, in the third column, for the words, figures, brackets and percentage "Nineteen and a half Percent (19.5%)", the words, figures and percentage "fifteen (15%)" may be substituted.
- **14.Mr. Ahmad Kundi, MPA** to move that in clause 10, in sub-clause (s), in the proposed Second Schedule, in Part-II, at serial No.2 in the second column, the shortened form and dot "etc." may be deleted.
- **15.Mr. Ahmad Kundi, MPA** to move that in clause 10, in sub-clause (s), in the proposed Second Schedule, in Part-II, at serial No.2, the sub serial no. iv, in the second and fourth columns may be deleted and the remaining sub serial nos. may be renumbered accordingly.
- **16. Ms. Sobia Shahid, MPA** to move that in clause 10, in sub-clause (s), in the proposed Second Schedule, in Part-II, at Serial No. 2, the sub-serial (v) may be deleted and the rest of the sub-serials may be renumbered accordingly.
- **17.Mr. Ahmad Kundi, MPA** to move that in clause 10, in sub-clause (s), in the proposed Second Schedule, in Part-II, at serial No.2, in the existing sub serial no. v, under CATEGORY-A, in the fourth column, for the figures "50,000" the figures "25,000" may be substituted.

- **18.Mr. Ahmad Kundi, MPA** to move that in clause 10, in sub-clause (s), in the proposed Second Schedule, in Part-II, at serial No.2, in the existing sub serial no. v, under CATEGORY-B, in the fourth column, for the figures "20,000", the figures "10,000" may be substituted.
- **19.Mr. Ahmad Kundi, MPA** to move that in clause 10, in sub-clause (s), in the proposed Second Schedule, in Part-II, at serial No.2, in the existing sub serial no. v, under CATEGORY-C, in the fourth column, for the figures "10,000", the figures "5,000" may be substituted.
- **20.Mr. Ahmad Kundi, MPA** to move that in clause 10, in sub-clause (s), in the proposed Second Schedule, in Part-II, at serial No.2, in the existing sub serial no. vi, in the fourth column, in sub serial no. (vi), for the figure "5", the figure "3" may be substituted.
- **21.Mr. Ahmad Kundi, MPA** to move that in clause 10, in sub-clause (s), in the proposed Second Schedule, in Part-II, at serial No.2, in the existing sub serial no. vii, in the fourth column, in sub serial no. (vii), for the figures "10" and "06", the figures "05" and "03" may be substituted, respectively.
- **22.Ms. Shehla Bano, MPA** to move that in clause 10, in sub-clause (s), in the proposed Second Schedule, in Part-II, at Serial No. 2, in sub-serial (vii) in the fourth column, for the expressions "Ten percent (10%)" and "Six percent (6%)", the expressions "Seven percent (7%)" and "Four percent (4%)" may be substituted, respectively.
- **23.Ms. Sobia Shahid, MPA** to move that in clause 10, in sub-clause (s), in the proposed Second Schedule, in Part-II, at Serial No. 16, the sub-serial (c) in the second column along-with its entry in the fourth column may be deleted.
- **24.Mr. Ahmad Kundi, MPA** to move that in clause 10, in sub-clause (s), after the Second Schedule, under the heading "Principles of Application and Interpretation:" in clause 1, for the words ", the applicable tax rate shall be the standard rate", the words "shall be exempted as if they are included in First Schedule" may be substituted.

## CLAUSE 11

- **1.Mr. Ahmad Kundi, MPA** to move that in clause 11, in clause (a), in clause (i), in sub-clause (b), in the proposed clause (h), after the word "Government", the words "and Federal Government" may be inserted.
- **2.Mr. Ahmad Kundi, MPA** to move that in clause 11, in clause (b), in the proposed proviso, after the words "defense-related", the words "or rescue and sanitary services-related", may be inserted and thereafter, after brackets and the abbreviation "(DEPO)", the words "or authorities of Rescue 1122 and WSSCs" may be inserted.
- **3. Mr. Aftab Alam Afridi MPA,** to move that in clause 11, after sub-clause (b), the following new sub-clause shall be inserted, namely:
  - "(b-i) in section 3, after sub-section (1), as so amended, the following new sub-section shall be inserted, namely:

"(1A) Notwithstanding anything contained in sub-section (1), Government may, by notification in the official Gazette, fix or specify any other rate of cess to be levied and collected, as determined on the basis of value of goods, net weight and distance, and may establish such rate on an incremental basis or otherwise, as deemed appropriate, for the purposes of this Act";"
