

SUBJECT: CALL ATTENTION NOTICE NO. 139

I am directed to refer to the subject noted above and to state that the Cabinet has been defined in the Government of Khyber Pakhtunkhwa Rules of Business, 1985 as "the Cabinet of Ministers appointed under Article 132 of the Constitution and includes the Chief Minister appointed under Article 130 of the Constitution".

Furthermore, Ministers, before entering upon their offices, make oath before the Governor, whereas Advisors and Special Assistants to the Chief Minister are appointed under Khyber Pakhtunkhwa Advisors and Special Assistants to the Chief Minister (Appointment) Act, 1989, without making any oath. Besides that, Ministers draw their perks and privileges under the Khyber Pakhtunkhwa Minister (Salaries, Allowances & Privileges) Act, 1975, whereas terms and conditions of the Advisors and Special Assistants to Chief Minister are determined by the Chief Minister under the Khyber Pakhtunkhwa Advisors and Special Assistants to the Chief Minister (Appointment) Act, 1989.

The instant case was taken up with Law Department and opined that "status of Provincial Minister on the advisor to Chief Minister can be conferred only for the purposes of perks and privileges and does not make the advisor as a provincial Minister, reliance is placed on the judgment in writ petitions No. 01 of 2020 dated 09-09-2020 of the Islamabad High Court Islamabad. Furthermore, the status of Provincial Minister was allowed to the Advocate General, Khyber Pakhtunkhwa without financial implications vide Notification dated 26-09-2024. It is further added that the Federal Government also grants status of the Federal Minister to the Advisor to Prime Minister.

Therefore, status of Provincial Minister has been granted to the Advisor to Chief Minister Khyber Pakhtunkhwa on Finance & IPC, however, he has neither taken Oath of the office of the Minister nor is any reference of the Article 132 of the Constitution given in the Notification.
