Subject: Condemnation of the Violation of Fundamental Rights of Mr. Imran Khan and Mrs. Bushra Bibi, and Demand for Restoration of Their Legal Entitlements

This House of the Provincial Assembly of Khyber Pakhtunkhwa unanimously adopts the following resolution:

The House strongly condemns the ongoing and egregious violations of the fundamental and human rights of Mr. Imran Khan, former Prime Minister of the Islamic Republic of Pakistan and former elected Member of the National Assembly, as well as the inhumane and degrading treatment of his wife, Mrs. Bushra Bibi, during their current incarcerations.

This Assembly expresses deep concern over the systematic denial of their constitutionally and legally guaranteed rights, including but not limited to:

1. The persistent and unjustified obstruction of Mr. Khan's fundamental right to meet and consult with legal counsel of his choosing, as well as with his sisters and close acquaintances, seriously impairing his right to a fair trial and due process.
2. The imposition of unreasonable restrictions on family visits, including the inexplicable and harsh denial of access to his sisters.
3. The reported degrading treatment of Mrs. Bushra Bibi, violating her dignity, privacy, and the established norms of human rights.
4. The denial of access to reading and writing materials for Mr. Khan, constituting a punitive and unnecessary restriction on his intellectual well-being and mental health.
5. The withholding of regular telephonic communication between Mr. Khan and his children, a right afforded to all prisoners under the law.

This House declares that these actions are in clear violation of the Constitution of the Islamic Republic of Pakistan, particularly:

- **Article 4:** Right of individuals to be dealt with in accordance with law;
- **Article 9:** Security of person;
- **Article 10:** Safeguards as to arrest and detention;
- **Article 14:** Inviolability of the dignity of man; and
- **Article 25:** Equality of citizens.

Furthermore, these actions contravene Pakistan's commitments under international human rights instruments and universally recognized standards of humane treatment.

Therefore, this Assembly demands:

- (a) The immediate and unconditional restoration of all legal and constitutional rights of Mr. Imran Khan and Mrs. Bushra Bibi;
- (b) An end to the mistreatment and humiliation of Mrs. Bushra Bibi;
- (c) Unrestricted access to legal counsel for Mr. Khan;
- (d) Resumption of regular family visits, including meetings with his sisters;
- (e) Provision of reading and writing materials;
- (f) Restoration of regular telephonic communication with his children.

This House further urges the Federal Government and all concerned authorities to ensure the safety, security, and dignified treatment of both Mr. Khan and Mrs. Bushra Bibi in accordance with the law and the Constitution of the Islamic Republic of Pakistan.
