Act**

*to amend the Khyber Pakhtunkhwa Tourism Act, 2019*

**WHEREAS** it is expedient to amend the Khyber Pakhtunkhwa Tourism Act, 2019 (Khyber Pakhtunkhwa Act No. XXVIII of 2019) for the purposes hereinafter appearing;

It is hereby enacted by the Provincial Assembly of Khyber Pakhtunkhwa as follows:


**1. Short title and commencement.**--- (1) This Act may be called the Khyber Pakhtunkhwa Tourism (Amendment) Act, 2025.

(2) It shall come into force at once.

**2. Amendment of section 24 of the Khyber Pakhtunkhwa Act No. XXVIII of 2019.**--- In the Khyber Pakhtunkhwa Tourism Act, 2019 (Khyber Pakhtunkhwa Act No. XXVIII of 2019), in section 24, in sub-section (3), for the existing proviso, the following shall be substituted, namely:

“Provided that,-

- (a) the Authority may hire their own Tourism Police once the Authority has developed the requisite capacity;
- (b) the Tourism Police, hired under clause (a), shall be on contract basis for a specific period, which may be extended for such period and on such terms and conditions as the Board may determine; and
- (c) the extension under clause (b) shall be for one-time which shall not exceed the initial period of the contract.”.
