further to amend the Provincial Motor Vehicles Ordinance, 1965

WHEREAS, it is expedient further to amend the Provincial Motor Vehicles Ordinance, 1965 (West Pakistan Ordinance No. XIX of 1965), for the purposes hereinafter appearing;

It is hereby enacted by the Provincial Assembly of Khyber Pakhtunkhwa as follows:

1. **Short title and commencement.**---(1) This Act be called the Provincial Motor Vehicles Ordinance (Khyber Pakhtunkhwa) (Amendment) Act, 2025.

(2) It shall come into force at once.

2. **General Amendment of the West Pakistan Ordinance No. XIX of 1965.**---In the Provincial Motor Vehicles Ordinance, 1965 (West Pakistan Ordinance No. XIX of 1965), hereinafter referred to as the said Ordinance, for the words "registration mark" or "registration number" wherever occurring in the said Ordinance, whether in the singular or plural form, the words "personalized registration mark" shall respectively be substituted, unless the context otherwise expressly requires.

3. **Amendment of section 2 of the West Pakistan Ordinance No. XIX of 1965.**---In the said Ordinance, in section 2,-

(a) in clause (23), after the words "and a trailer", the words "and shall include all types and kinds of automobiles, motor vehicles including hybrid electric vehicle, battery electric vehicle, electric vehicle, extended range electric vehicle, plug-in hybrid electric vehicle etc." shall be inserted;

(b) after clause (23), as so amended, the following new clauses shall be inserted, namely:

"(23A) "personalized registration mark" means a registration mark, a number plate or any other shape, type or document, assigned to the owner of a motor vehicle, containing alphanumeric characters or symbols etc. as specified by the Department;

(23B) "vehicle identification number" means the chassis number of a motor vehicle, which shall be used as identification number for all purposes;" and

(c) in clause (24), after the word "registered", the words "with a personalized registration mark" shall be inserted.

4. Insertion of section 25A to the Ordinance No. XIX of 1965.---In the said Ordinance, after section 25, the following new section 25A shall be inserted, namely:

“25A. Allotment of personalized registration mark.---(1) The registering authority, during the process of a registration, shall allot personalized registration mark to the owner of a motor vehicle, which shall be retained by the owner at the time of sale of a motor vehicle. Separate personalized registration mark shall be issued to an owner, having more than one motor vehicles.

(2) The personalized registration mark shall stand deactivated as soon as the owner has sold the vehicle, till the request for activation by the owner for applying it to another motor vehicle has been received by the registering authority. An owner may retain a deactivated personalized registration mark, subject to yearly biometric verification, which may be retained by the owner for a period of three years, without applying it to a motor vehicle. At the expiry of three years, the personalized registration mark shall stand cancelled and the owner shall surrender the number plates to the original registering authority.

(3) An owner shall apply for a new personalized registration mark, only when personalized registration mark already allotted to him is activated, subject to the conditions laid down under this Ordinance and any other legal, regulatory regime for the time being in force.

(4) The owner of a personalized registration mark may voluntarily surrender the personalized registration mark by submitting an application to the original registering authority.

(5) In case the owner of an activated personalized registration mark desires to have his existing personalized registration mark cancelled and instead have a new personalized registration mark issued in his name, he shall file an application to the original registering authority, which shall, subject to the provisions of this Ordinance, have the existing personalized registration mark cancelled and a new one issued to the owner at a fixed fee of rupees ten thousand (10,000).

(6) In case of death of an owner, the personalized registration mark(s) shall remain valid for transferring to the next of kin as per the applicable inheritance laws, for the time being in force.

(7) The personalized registration mark may be re-issued to a new owner, subject to such conditions as specified under this Ordinance and any other legal or regulatory regime for the time being in force, in the following cases:

- (a) where no legal heir of the deceased owner exists;
- (b) where the owner willingly surrenders it; or
- (c) on the expiry of deactivation period.

(8) All the registered number plates, issued or allotted, prior to the commencement of the Provincial Motor Vehicles Ordinance (Khyber Pakhtunkhwa) (Amendment) Act, 2025, shall be considered as "personalized registration mark" and chassis number of these vehicles shall be taken as vehicle identification number, with applicability of all the provisions of this Ordinance.

(9) The provisions of this section shall be applicable to all kinds of motor vehicles except motor vehicles owned by Government and semi-Government organization."

5. **Amendment of section 43 of the West Pakistan Ordinance No. XIX of 1965.**---In the said Ordinance, in section 43, in sub-section (2), in clause (m), the fullstop appearing at the end shall be replaced by a semi-colon, and thereafter the following new clauses shall respectively be added, namely:

"(n) exhibition, registration and activation or deactivation of personalized registration marks, including procedures, conditions, and related fees; and

(o) the prescribed authority, or any officer authorized by it, may, for the purpose of ensuring compliance with the provisions of this Ordinance, conduct roadside checks of motor vehicles and examine personalized registration marks, relevant documents, vehicle identification number, engine number, place and registration particulars."

6. **Insertion of section 97A to the West Pakistan Ordinance No. XIX of 1965.**---In the said Ordinance, after section 97, the following new section 97A shall be inserted, namely:

"97A. **Penalty for fabrication of personalized registration mark.**---Notwithstanding anything contained in this Ordinance, any person, who fabricates or counterfeits a personalized registration mark or number plate to be provided by the prescribed authority or the registering authority under section 25A or uses any mechanism to disable identification, whether manual or machine enabled, shall be punished with fine which shall be equal to the amount of annual motor tax and the personalized registration mark of such motor vehicle shall be cancelled. Till the payment of fine the motor vehicle shall remain impounded.

7. **Amendment of the First Schedule of the West Pakistan Ordinance No. XIX of 1965.**---In the said Ordinance, in the First Schedule,-

(a) for Form F, the following shall be substituted, namely:
