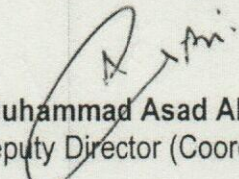

According to Rule 111 of the Election Rules, 2017, each voter (Member Provincial Assembly) is required to have with him Identity Card, issued to him by the Secretary, Provincial Assembly, on Polling Day, and, shall, if so required, show the same to the Returning Officer before the Ballot Paper is issued to him. All the members of the Provincial Assembly of Khyber Pakhtunkhwa, may be informed accordingly besides advising them to bring their respective Assembly Identity Cards with them at the time of casting their vote.

It is further, requested that necessary arrangements for setting up of the Polling Station on the Poll Day may be made in the Provincial Assembly, Khyber Pakhtunkhwa, and confirmation in this context may be communicated to the Provincial Election Commissioner, Khyber Pakhtunkhwa /Returning Officer as well as to this Commission.
