No.PA/Khyber Pakhtunkhwa/Bills-56/2025/5802.— The Khyber Pakhtunkhwa (Appointment, Deputation, Posting and Transfer of Teachers, Lectures, Instructors and Doctors) Regulatory (Amendment) Bill, 2025 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 25th August, 2025 and assented to by the Governor of the Khyber Pakhtunkhwa on 03rd September, 2025 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

THE KHYBER PAKHTUNKHWA (APPOINTMENT, DEPUTATION, POSTING AND TRANSFER OF TEACHERS, LECTURERS, INSTRUCTORS AND DOCTORS) REGULATOLRY (AMENDMENT) ACT. 2025. (KHYBER PAKHTUNKHWA ACT NO. XXI OF 2025)

(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa.

(Extraordinary), dated the 09th September, 2025).

AN ACT

to amend the Khyber Pakhtunkhwa (Appointment, Deputation, Posting and Transfer of Teachers, Lecturers, Instructors and Doctors)

Regulatory Act, 2011

WHEREAS it is expedient to amend the Khyber Pakhtunkhwa (Appointment, Deputation, Posting and Transfer of Teachers, Lecturers, Instructors and Doctors) Regulatory Act, 2011(Khyber Pakhtunkhwa Act No. XII of 2011) for the purposes hereinafter appearing;

It is hereby enacted by the Provincial Assembly of Khyber Fakhtunkhwa as follows:

- 1. Short title and commencement.---(1) This Act may be called the Khyber Pakhtunkhwa(Appointment, Deputation, Posting and Transfer of Teachers, Lecturers, Instructors and Doctors) Regulatory (Amendment) Act, 2025.
 - (2) It shall come into force at once.

- 2. Amendment of section 2 of the Khyber Pakhtunkhwa Act No. XII of 2011.—In the Khyber Pakhtunkhwa (Appointment, Deputation, Posting and Transfer of Teachers, Lecturers, Instructors and Doctors) Regulatory Act, 2011 (Khyber Pakhtunkhwa Act No. XII of 2011), hereinafter referred to as the said Act, in section 2, in sub-section (1), after clause (b), the following new clause shall be inserted, namely:
 - "(b-i) "educational cluster" means a group of schools as notified by the Elementary & Secondary Education Department from time to time for the purpose of this Act, consisting of not more than seven (07) Village Councils and Neighborhood Councils, as the case may be;".
- 3. Amendment of section 3of the Khyber Pakhtunkhwa Act No. XII of 2011.---In the said Act, in section 3,
 - in sub-sections (1), (2), (3) and (4), for the words "Union Council" and "Union Councils", wherever occurring, the word "educational cluster" and "educational clusters" shall respectively be substituted; and
 - (b) after sub-section (4), as so amended, the following new sub-section shall be added, namely:
 - "(5) Notwithstanding anything contained in the relevant laws, rules or regulations, all appointments made under sub-section (1),till the commencement of the Khyber Pakhtunkhwa (Appointment, Deputation, Posting and Transfer of Teachers, Lecturers, Instructors and Doctors) Regulatory (Amendment) Act, 2025,against the posts of primary school teacher at Union Council/Sub-Division/Tehsil/District level in the settled and merged Districts of Khyber Pakhtunkhwa, as the case may be, shall be deemed as validly made and shall not be called into question in any Court of law or any other forum."
