No.PA/Khyber Pakhtunkhwa/Bills-60/2025/6778.— The Khyber Pakhtunkhwa Charities (Amendment) Bill, 2025 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 08th September, 2025 and assented to by the Governor of the Khyber Pakhtunkhwa on 25th September, 2025 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

further to amend the Khyber Pakhtunkhwa Charities Act, 2019.

WHEREAS it is expedient further to amend the Khyber Pakhtunkhwa Charities Act, 2019 (Khyber Pakhtunkhwa Act No. XXIX of 2019), for the purposes hereinafter appearing;

It is hereby enacted by the Provincial Assembly of Khyber Pakhtunkhwa as follows:

1. **Short title and commencement.**---(1) This Act may be called the Khyber Pakhtunkhwa Charities (Amendment) Act, 2025.

(2) It shall come into force at once.

2. **Amendment of section 12 of the Khyber Pakhtunkhwa Act No. XXIX of 2019.**---
In the Khyber Pakhtunkhwa Charities Act, 2019 (Khyber Pakhtunkhwa Act No. XXIX of 2019), in section 12, for sub-section (1) the following shall be substituted, namely:

“(1) Irrespective of registration of charity under any law for the time being in force, every charity shall get itself registered with the registering authority, on payment of such a fee as may be prescribed by the Commission:

Provided that the registration certificate, issued by the registering authority in pursuance of this sub-section, shall be valid for a period of two years, from the date of issuance, which shall be renewable, on payment of such renewal fee, as may be prescribed by the Commission.”.
