No.PA/Khyber Pakhtunkhwa/Bills-67/2025/6257.— The Khyber Pakhtunkhwa Tourism (Amendment) Bill, 2025 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 02nd September, 2025 and assented to by the Governor of the Khyber Pakhtunkhwa on 10th September, 2025 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

THE KHYBER PAKHTUNKHWA TOURISM (AMENDMENT) ACT, 2025. (KHYBER PAKHTUNKHWA ACT NO. XXIV OF 2025)

AN ACT

to amend the Khyber Pakhtunkhwa Tourism Act, 2019

WHEREAS it is expedient to amend the Khyber Pakhtunkhwa Tourism Act, 2019 (Khyber Pakhtunkhwa Act No. XXVIII of 2019) for the purposes hereinafter appearing;

It is hereby enacted by the Provincial Assembly of Khyber Pakhtunkhwa as follows:

- 1. Short title and commencement.---(1) This Act may be called the Khyber Pakhtunkhwa Tourism (Amendment) Act, 2025.
 - (2) It shall come into force at once.
- 2. Amendment of section 24 of the Khyber Pakhtunkhwa Act No. XXVIII of 2019.--In the Khyber Pakhtunkhwa Tourism Act, 2019 (Khyber Pakhtunkhwa Act No. XXVIII of 2019), in section 24,in sub-section (3), for the existing proviso, the following shall be substituted, namely:

"Provided that,-

- (a) the Authority may hire their own Tourism Police once the Authority has developed the requisite capacity;
- (b) the Tourism Police, hired under clause (a), shall be on contract basis for a specific period, which may be extended for such period and on such terms and conditions as the Board may determine; and
- (c) the extension under clause (b) shall be for one-time which shall not exceed the initial period of the contract.".
