Bill**

to amend the Khyber Pakhtunkhwa Adhoc Lecturers (Regularization of Services) Act, 2014

WHEREAS it is expedient to amend the Khyber Pakhtunkhwa Adhoc Lecturers (Regularization of Services) Act, 2014 (Khyber Pakhtunkhwa Act No. XXII of 2014), for the purposes hereinafter appearing;

It is hereby enacted by the Provincial Assembly of Khyber Pakhtunkhwa as follows:

1. Short title and commencement.---(1) This Act may be called the Khyber Pakhtunkhwa Adhoc Lecturers (Regularization of Services) (Amendment) Act, 2025.

(2) It shall come into force at once.

2. Amendment of the Preamble of the Khyber Pakhtunkhwa Act No. XXII of 2014.--- In Khyber Pakhtunkhwa Adhoc Lecturers (Regularization of Services) Act, 2014 (Khyber Pakhtunkhwa Act No. XXII of 2014), hereinafter referred to as the said Act, in the Preamble, after the first paragraph, the following new paragraph shall be inserted, namely:

“WHEREAS it is expedient to provide for the regularization of one hundred and twelve (112) male and ninety-six (96) female adhoc lecturers, appointed by erstwhile FATA Secretariat;”.

3. Amendment of section 2 of the Khyber Pakhtunkhwa Act No. XXII of 2014.--- In the said Act, in section 2, in sub-section (1), in clause (e), after the words “the Khyber Pakhtunkhwa”, the words “and adhoc lecturers appointed by erstwhile FATA Secretariat” shall be inserted.

4. Amendment of section 3 of the Khyber Pakhtunkhwa Act No. XXII of 2014.--- In the said Act, in section 3, in sub-section (1),-

- (a) after the words “commencement of this Act”, wherever is occurring, the letters, dots, figures, word and comma “i.e. 26th May, 2014”, shall be inserted; and
- (b) in clause (b), after the words “under this Act”, the letters, dots, figures, word and comma “w.e.f. 26th May, 2014”, shall be inserted.

5. Amendment of section 4 of the Khyber Pakhtunkhwa Act No. XXII of 2014.--- In the said Act, in section 4, in sub-section (1), after the words “commencement of this Act”, the letters, dots, figures, word and comma “i.e. 26th May, 2014”, shall be inserted.

6. **Addition of new section 6 in the Khyber Pakhtunkhwa Act No. XXII of 2014.**--- In the said Act, after section 5, the following new section shall be added, namely:

“6. Removal of difficulties.--- If any difficulty arises in giving effect to any of the provisions of this Act, the Chief Minister of Khyber Pakhtunkhwa may make such order, not inconsistent with the provisions of this Act, as may appear to him to be necessary for the purpose of removing such difficulty.”.

STATEMENT OF OBJECTS AND REASONS

It is expedient to provide for the regularization of the conditionally regularized one hundred and twelve (112) male and ninety-six (96) female lecturers in pursuance of the Peshawar High Court Judgment dated: 24.05.2017.

The provision regarding removal of difficulty if arises while giving effect to any of the provisions of the Act is also required to be inserted. Hence, this Bill.
