During the meeting, the matter regarding repair and maintenance of transformers was thoroughly discussed and the enclosed (Annex-I) guidelines were proposed.

STANDARD GUIDELINES
FOR REPAIR AND MAINTENANCE OF TRANSFORMER

1. The PC-I for each area should be approved from the competent forum of District Development Committee.✓
2. The cost estimate of the scheme incorporating the value of scrap / salvage should be prepared based on the prevailing MRS / NSI, notified by Government of Khyber Pakhtunkhwa.
3. The contractors / firms to be participating in the e-bidding process, Local Government and Rural Development Department must be enlisted with Centralized Enlistment Committee, C&W Department and having relevant codes of PEC for the subject purpose.
4. The scheme shall be executed through contractors / firms / workshops registered with PESCO / WAPDA.
5. The local community and Secretary VC/NC shall facilitate the Assistant Director Office in the entire process of repair / maintenance of transformer.
6. The damaged transformer shall be pre and post both inspected in close coordination with PESCO / WAPDA authorities.
7. The repair and maintenance of transformers work should be carried out by taking all the necessary safety precautions and measures and in close coordination with PESCO / WAPDA and District Administration.
