REQUEST FOR IN-CAMERA BRIEFING TO THE SPECIAL COMMITTEE
(ON SECURITY), PROVINCIAL ASSEMBLY OF KHYBER
PAKHTUNKHWA.

Dear Sir,

I am directed to refer to the subject cited above and to convey that, in its sitting held on 8th September, 2025, the Provincial Assembly of Khyber Pakhtunkhwa constituted a Special Committee on Security to examine the prevailing law and order and overall security situation in the Province. The Committee comprises more than forty Members, including the Leader of the House, Leader of the Opposition, Provincial Ministers, Parliamentary Leaders of respective political parties, and Members of the Provincial Assembly, reflecting a broad-based and representative forum of the House.

2. In pursuance of its mandate, the Committee has received detailed briefings from key stakeholders, including the Chief Secretary, the Additional Chief Secretary (Home & Tribal Affairs Department) and the Inspector General of Police, Khyber Pakhtunkhwa, which are regarded as essential inputs for the Committee prior to the finalization of its findings and the presentation of its report to the Provincial Assembly.
3. Pertinently, in its second meeting, the Committee further resolved to engage all political parties and relevant stakeholders across the Province. In pursuance thereof, the Khyber Pakhtunkhwa Peace *Jirga*, 2025 was convened and hosted by the Provincial Assembly on 12th December, 2025 resulting in the unanimous adoption of a comprehensive declaration outlining a roadmap for long-term peace and stability in the Province. The declaration was also shared with the Federal Government for consideration.
4. In continuation of the consultative process, the Committee desires to receive a detailed briefing from Headquarters XI Corps, Peshawar, particularly in the context of the ongoing operations being conducted by the Federal Government and law enforcement agencies in the merged districts of Khyber Pakhtunkhwa. The committee acknowledges the importance of security measures, however, it considers that operation alone, without broader political, social, and developmental initiatives, may not ensure sustainable peace and stability and could risk further unrest in the Province.

In view of the sensitivity of the matter, I am further directed to request that in-camera briefing for the Special Committee (on Security) kindly be arranged at Provincial Assembly of Khyber Pakhtunkhwa on a mutually convenient date and time.

The Committee would highly appreciate your cooperation in this regard which will assist it in discharging its constitutional responsibility.


