Subject: - **JOINT RESOLUTION No. 239 ADOPTED BY THE PROVINCIAL
ASSEMBLY OF KHYBER PAKHTUNKHWA.**

Dear Sir,

I am directed to say that the Provincial Assembly of Khyber Pakhtunkhwa in its sitting held on **20-04-2026** passed unanimously the following Joint Resolution No.239 moved by Mr. Sher Ali Afridi, Mr. Aftab Alam, Minister for Law, Mr. Taj Muhammad, Advisor to Chief Minister Khyber Pakhtunkhwa, Mr. Arshad Ali, Mr. Nazir Ahmad Abbasi, Muhammad Idrees, Mr. Zubair Khan, Syed Qasim Ali Shah, Mr. Hamid ur Rahman (PK-19) and Mian Sharafat Ali, Members Provincial Assembly of Khyber Pakhtunkhwa. The resolution is given below:-

“WHEREAS, peace, stability and regional cooperation constitute indispensable prerequisites for the long-term security of Pakistan, its sustainable development, economic prosperity, and enhanced standing in the comity of nations;

AND WHEREAS, Imran Khan, Founder Chairman of Pakistan Tehreek-e-Insaf and former Prime Minister of Pakistan, consistently advocated a foreign policy framework grounded in dialogue, diplomatic engagement and peaceful coexistence among States;

AND WHEREAS, during his tenure as Prime Minister, Pakistan under his leadership played a constructive role in advancing regional peace efforts, including facilitation of understandings contributing to the Doha Process aimed at the cessation of prolonged conflict in Afghanistan and undertook initiatives to promote meaningful engagement between regional actors, thereby reinforcing Pakistan's potential as a bridge-builder in international diplomacy.

AND WHEREAS, his landmark initiative of opening the Kartarpur Corridor stands as a historic gesture of interfaith harmony, religious tolerance, and enhanced people-to-people connectivity, while his consistent articulation of the principle that Pakistan shall remain a partner in peace and not in conflict continue to provide a guiding orientation for a dignified and balanced foreign policy.

AND WHEREAS, notwithstanding his present incarceration, the vision and political philosophy espoused by him for peace, dialogue and regional stability continue to find resonance in national discourse and the proposed Islamabad Peace Dialogue presents a timely opportunity to further strengthen efforts for regional harmony through structured and sustained diplomatic engagement;

THEREFORE, the Provincial Assembly of Khyber Pakhtunkhwa resolves to reaffirm its support for the Islamabad Peace Dialogue as a meaningful and constructive initiative aimed at the promotion of peace, regional stability and sustained diplomatic engagement in the region.

The Assembly records its appreciation of the contributions of Mr. Imran Ahmad Khan Niazi, Founder Chairman, PTI in consistently promoting dialogue-based diplomacy and a peace-oriented foreign policy and reaffirms that long-standing advocacy for political dialogue as the sole viable means for durable peace, coupled with his caution that conflict aggravates poverty and human suffering, constitutes a coherent and enduring framework relevant to contemporary peace efforts;

Furthermore, the Assembly is of the considered view that, in order to enhance the inclusivity, credibility and effectiveness of the Islamabad Peace Dialogue, it would be appropriate that his vision, experience and political mandate as a significant stakeholder are duly acknowledged and meaningfully reflected within the consultative and deliberative processes aimed at advancing regional peace, stability and socio-economic well-being”

You are, therefore requested that action taken on the resolution may be intimated to this Secretariat within a period of ninety days from the date of its communication under sub-rule (2) of Rule 165 of the Provincial Assembly of Khyber Pakhtunkhwa Procedure and Conduct of Business Rules, 2025 for circulation amongst the Members of the Assembly.
