No. PA/Khyber Pakhtunkhwa/Bills-43/2026/5488.— The Khyber Pakhtunkhwa Public Financial Management (Amendment) Bill, 2026 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 13th April, 2026 and deemed to have been assented to by the Governor of the Khyber Pakhtunkhwa on 27th April, 2026 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

THE KHYBER PAKHTUNKHWA PUBLIC FINANCIAL MANAGEMENT (AMENDMENT) ACT, 2026.
(KHYBER PAKHTUNKHWA ACT NO. VI OF 2026)

(First published after having received the assent of the Governor of the Khyber Pakhtunkhwa in the Gazette of the Khyber Pakhtunkhwa. (Extraordinary), dated the 28th April, 2026).

ACT**

to amend the Khyber Pakhtunkhwa
Public Financial Management Act, 2022.

WHEREAS it is expedient to amend the Khyber Pakhtunkhwa Public Financial Management Act, 2022 (Khyber Pakhtunkhwa Act No. XXIX of 2022), for the purposes hereinafter appearing;

It is hereby enacted by the Provincial Assembly of Khyber Pakhtunkhwa as follows:

1. **Short title and commencement.**---(1) This Act may be called the Khyber Pakhtunkhwa Public Financial Management (Amendment) Act, 2026.

(2) It shall come into force at once.

2. Amendment of section 2 of the Khyber Pakhtunkhwa Act No. XXIX of 2022.---In the Khyber Pakhtunkhwa Public Financial Management Act, 2022 (Khyber Pakhtunkhwa Act No. XXIX of 2022), hereinafter referred to as the said Act, in section 2, clause (m) shall be deleted.

3. Amendment of section 13 of the Khyber Pakhtunkhwa Act No. XXIX of 2022.---In the said Act, in section 13,-

(a) sub-section (2) shall be deleted; and

(b) for sub-section (3), the following shall be substituted, namely:

“(3) Monies shall not be withdrawn from the Provincial Consolidated Fund and Public Account, unless released and authorized by the Finance Department.”.

4. Substitution of section 18 of the Khyber Pakhtunkhwa Act No. XXIX of 2022.---In the said Act, for section 18, the following shall be substituted, namely:

“**18. Commitment Control System.**---The Finance Department shall issue instructions related to annual and multi-annual commitment control system.”.

5. Amendment of section 20 of the Khyber Pakhtunkhwa Act No. XXIX of 2022.---In the said Act, in section 20, for sub-section (2), the following shall be substituted, namely:

“(2) The Finance Department shall issue guidelines for internal controls in all departments and other institutional units forming part of Government.”.
