No. PA/Khyber Pakhtunkhwa/Bills-82/2026/6389.— The Khyber Pakhtunkhwa Universities (Amendment) Bill, 2026 having been passed by the Provincial Assembly of Khyber Pakhtunkhwa on 27th April, 2026 and assented to by the Governor of the Khyber Pakhtunkhwa on 06th May, 2026 is hereby published as an Act of the Provincial Legislature of the Khyber Pakhtunkhwa.

THE KHYBER PAKHTUNKHWA UNIVERSITIES (AMENDMENT) ACT, 2026 (KHYBER PAKHTUNKHWA ACT NO. X OF 2026)

AN ACT

further to amend the Khyber Pakhtunkhwa Universities Act, 2012

WHEREAS it is expedient further to amend the Khyber Pakhtunkhwa Universities Act, 2012 (Khyber Pakhtunkhwa Act No. X of 2012), for the purposes hereinafter appearing;

It is hereby enacted by the Provincial Assembly of Khyber Pakhtunkhwa as follows:

1. **Short title and commencement.**--- (1) This Act may be called the Khyber Pakhtunkhwa Universities (Amendment) Act, 2026.

(2) It shall come into force at once.

2. **Amendment of SCHEDULE-I of the Khyber Pakhtunkhwa Act No. X of 2012.**--- In the Khyber Pakhtunkhwa Universities Act, 2012 (Khyber Pakhtunkhwa Act No. X of 2012), hereinafter referred to as the said Act, in SCHEDULE-I, for Serial No. 30, the following shall be substituted, namely:

"(30) The University of Computing Sciences and Information Technology, Swat."

3. **Amendment of SCHEDULE-II of the Khyber Pakhtunkhwa Act No. X of 2012.**--- In the said Act, in SCHEDULE-II, in PART 'A', against Serial No. 2, under the heading "Essential Qualification and Experience", in clause (a),-

(a) in sub-clauses (v) and (vi), the word "and", appearing at the end, shall respectively be deleted; and

(b) in clause (vii), after the semicolon, appearing at the end, the word "and" shall be added and thereafter, the following new sub-clause shall be added, namely:

"(viii) for Computing Sciences and Information Technology University, Ph.D in the field of Computing Sciences and Information Technology;".
