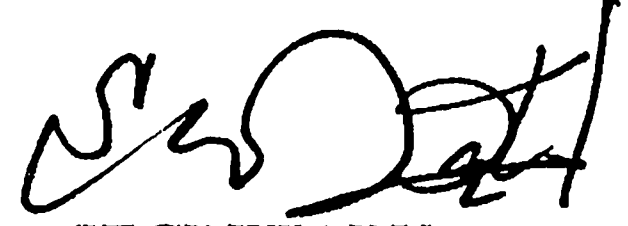

further to amend the Khyber Pakhtunkhwa Local Government Act, 2013

WHEREAS it is expedient to amend the Khyber Pakhtunkhwa Local Government Act, 2013 (Khyber Pakhtunkhwa Act No. XXVIII of 2013), for the purposes hereinafter appearing;

It is hereby enacted by the Provincial Assembly of Khyber Pakhtunkhwa as follows:

1. **Short title and commencement.**---(1) This Act may be called the Khyber Pakhtunkhwa Local Government (Amendment) Act, 2026,

(2) It shall come into force at once.

2. **Amendment of section 6 of the Khyber Pakhtunkhwa Act No. (XXVIII).**---In the Khyber Pakhtunkhwa Local Government Act, 2013, in section 6, in sub-section (5), for clause (c), the following shall be substituted, namely:—

"(c) the population of a Village Council and Neighbourhood Council, within a district, shall range between thirty thousand (30000) to forty thousand (40000), with ten percent (10%) permissible variation, calculated on the basis of the Digital Census 2023, officially published:

Provided that in specific cases, the Election Commission of Pakistan may, for reasons to be recorded, waive any of the aforesaid condition after due consultation with Government."
