further to amend the Stamp Act, 1899.

WHEREAS it is expedient further to amend the Stamp Act, 1899 (Act No. II of 1899), for the purposes hereinafter appearing:

It is hereby enacted by the Provincial Assembly of Khyber Pakhtunkhwa as follows:

1. **Short title and commencement.**--- (1) This Act may be called the Khyber Pakhtunkhwa Stamp (Amendment) Act, 2025.

(2) It shall come into force at once.

2. **Amendment of section 27A of Act No. II of 1899.**--- In the Stamp Act, 1899 (Act No. II of 1899), hereinafter referred to as the said Act, in section 27A.-

(a) in the marginal heading, the word "Urban" shall be deleted; and

(b) in sub-section (1), for the words, parenthesis, letters and figures "clause (b) of Article 23 or clause (b) of Article 23 or clause (b) of Article 31", the words and figures "Article 23 or Article 31 or Article 33" shall be substituted.

3. **Amendment of section 29 of Act No. II of 1899.**--- In the said Act, in section 29, in clause (c),-

(a) after the word "grantee", the words "and grantor in equal shares" shall be inserted; and

(b) for the word "or", appearing after the word "lessee", the word "and" shall be substituted.

4. **Amendment of section 32 of Act No. II of 1899.**--- In the said Act, in section 32, in sub-section (3),-

(a) for the word "do", appearing after the word "stamped", the word "or" shall be substituted; and

(b) for the word "acters", appearing after the words "may be", the word "acted" shall be substituted.

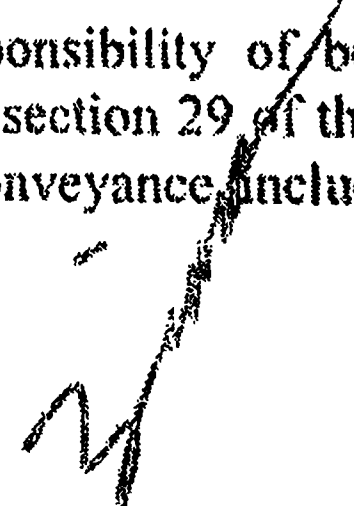
STATEMENT OF OBJECTS AND REASONS

The marginal heading of section 27A of the Stamp Act, 1899 needs to be amended as the word "Urban" restricts its application to the rural land as well as certain references of Schedule-I mentioned therein.

It is also desirable to provide for sharing the responsibility of bearing the expenses duty of providing proper stamp under clause (c) of section 29 of the Act ibid by grantee and grantor in equal shares in the case of a conveyance including a re-conveyance of mortgaged property. Hence, this Bill.
