Act**

To amend the Khyber Pakhtunkhwa Provincial Assembly (Powers, Immunities and Privileges) Act, 2026.

WHEREAS the Provincial Assembly of Khyber Pakhtunkhwa has enacted the Khyber Pakhtunkhwa Provincial Assembly (Powers, Immunities and Privileges) Act, 2026 under Article 66 read with Article 127 of the Constitution of the Islamic Republic of Pakistan to define the powers, immunities and privileges of the Provincial Assembly and its Committees, and the immunities and privileges of Members of the Provincial Assembly:

AND WHEREAS it is expedient to amend the Khyber Pakhtunkhwa Provincial Assembly (Powers, Immunities and Privileges) Act, 2026 (Khyber Pakhtunkhwa Act No. VII of 2026) for the purposes hereinafter appearing;

It is hereby enacted as follows:

1. Short title and commencement.---(1) This Act may be called the Khyber Pakhtunkhwa Provincial Assembly (Powers, Immunities and Privileges) (Amendment) Act, 2026.

(2) It shall come into force at once.

2. Amendment of section 13 of the Khyber Pakhtunkhwa Act No. VII of 2026.---
In the Khyber Pakhtunkhwa Provincial Assembly (Powers, Immunities and Privileges) Act, 2026 (Khyber Pakhtunkhwa Act No. VII of 2026), hereinafter referred to as the "said Act", in section 13,-

(a) for clause (b), the following shall be substituted, namely:

" (b) granting of four arms licenses of non-prohibited bore weapons on gratis basis for lifetime;" and

(b) for clause (i), the following shall be substituted, namely:

"(i) official passport, which shall remain valid during their parliamentary tenure, as per prevailing federal laws".

3. Amendment of the First schedule of the Khyber Pakhtunkhwa Act No. VII of 2026.---In the said Act, in the First Schedule,-

- (a) against Serial No. 11, in Column No. 3, for the words “six” and “one million”, the words “three” and “three hundred thousand” shall respectively be substituted;
- (b) against Serial No. 12, in Column No. 3, for the words “six” and “five hundred thousand”, the words “three” and “one hundred thousand” shall respectively be substituted;
- (c) against Serial No. 13, in Column No. 3, for the words “six” and “one million”, the words “three” and “three hundred thousand” shall respectively be substituted; and
- (d) against Serial No. 14, in Column No. 3, for the words “six” and “one million”, the words “three” and “three hundred thousand” shall respectively be substituted.
